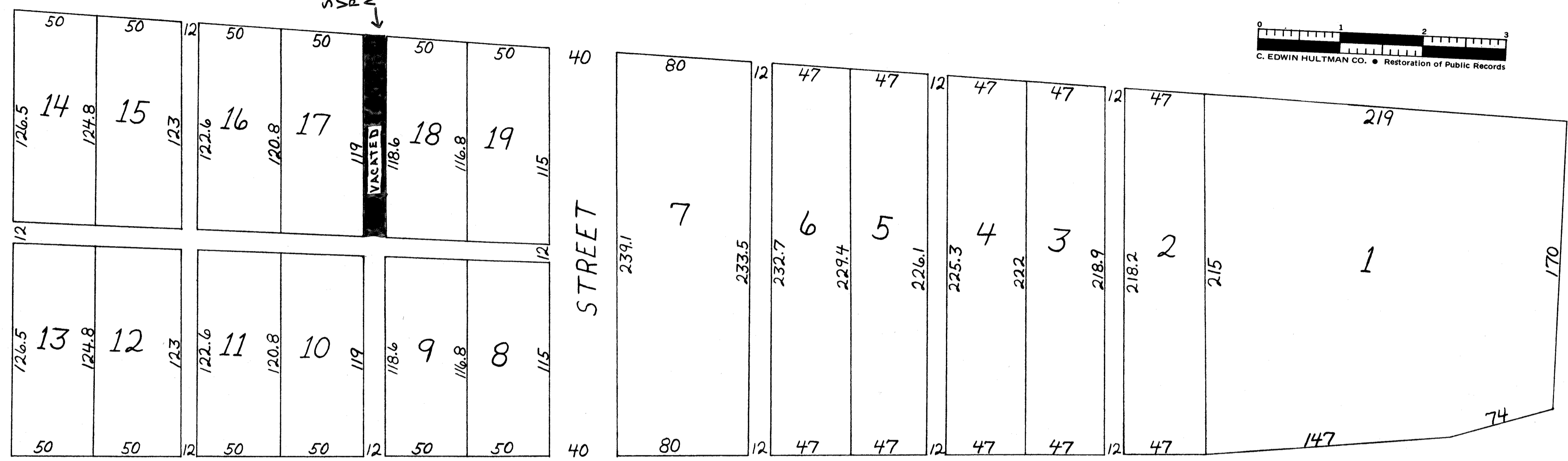

JACOB F. SECREST'S FIRST ADDITION TO PT. PLEASANT

BY THE REQUEST AND DIRECTION OF J.F. SECREST, OWNER, THEREOF, I SURVEYED A PIECE OF LAND IN VALLEY TOWNSHIP, IT BEING A PART OF LOT 8, OF TOWNSHIP 8 OF RANGE 9 AND BOUNDED BY BEGINNING AT THE SOUTHEAST CORNER OF 9.97 ACRES SOLD JUNE 15, 1893 BY SAID J.F. SECREST TO GEO. J. MARKLEY: THENCE N. 19 W. 265 FEET TO A POINT ON A LINE MADE BY CONTINUING THE SOUTH SIDE OF MAIN ST. IN PT. PLEASANT; THENCE EASTERLY ON SAID LINE 914 FEET THENCE S. 19 E. 170 FEET THENCE S. 54 W. 74 FEET THENCE S. 67 W. 147 FEET THENCE S. 71 W. 715 FEET TO BEGINNING. ALSO I LAID OUT THE SAME INTO LOTS, A STREET AND ALLEYS AS SHOWN BY THE ACCOMPANYING PLAT. THE DISTANCES ARE GIVEN IN FEET AND DECIMALS AND MARKED IN BLACK INK. THE LOT NUMBER IS PLACED ON EACH LOT IN RED INK.
