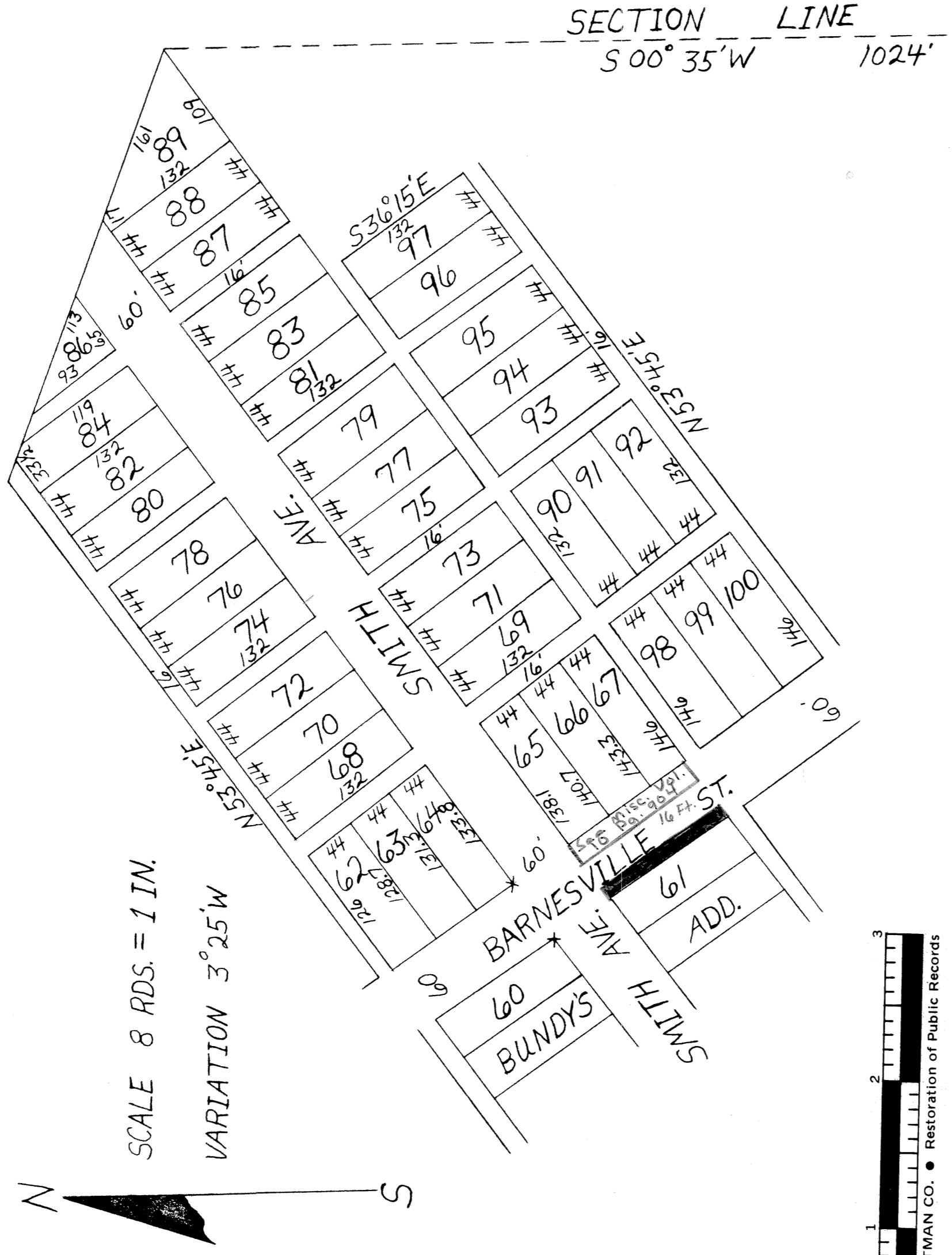


A. COCHRAN'S SECOND ADDITION
