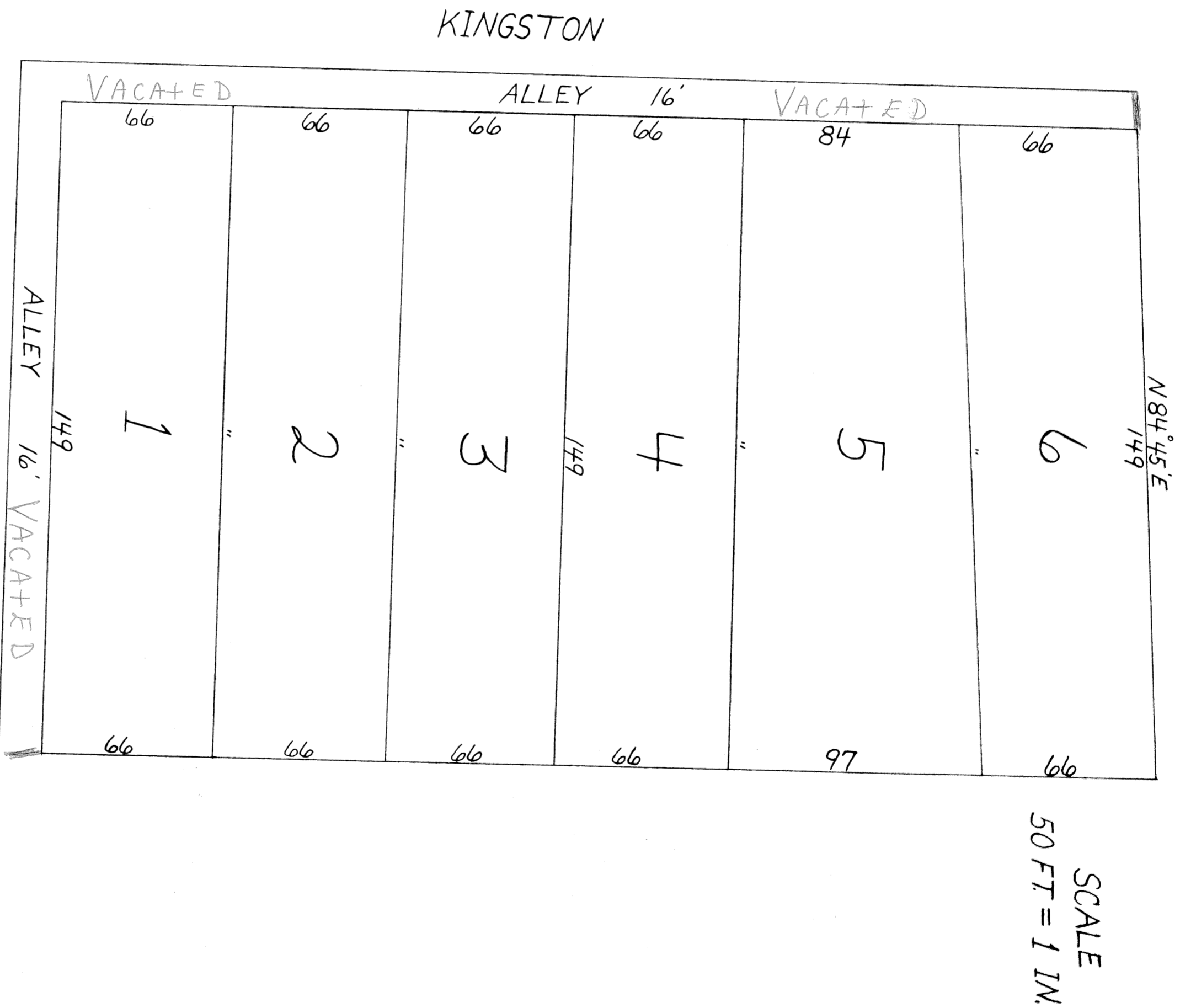


# PEARSON'S ADDITION TO KINGSTON
