WE THE UNDERSIGNED PROPRIETORS OF THE ACCOMPANYING PLAT OF ADDITION TO THE TOWN OF BYESVILLE DO HEREBY CERTIFY THAT THE SURVEY AND PLAT THERE OF WERE MADE AT OUR REQUEST AND BY OUR DIRECTIONS AND THAT THE ALLEYS THEREIN CONTAINED ARE GIVEN FOR PUBLIC USE AND CONVENIENCE OF SAID LOTS.

AT THE REQUEST OF JOHN HOOD AND ELIJAH MILLHONE I MADE THE FOLLOWING SURVEY ON MILITARY LOT NO. 2 IN THE S.E. QR OF TWP. NO. 1 RANGE NO. 3 OF THE ZANESVILLE LAND DISTRICT NOW A PART OF JACKSON TWP. GUERNSEY CO. O. BEGINNING AT A STONE THAT IS 264 FEET NORTH OF A STONE IN THE S. LINE OF MILITARY LOT NO. 2 AND THE S.E. CORNER OF AN ACRE OF LAND OWNED BY JOHN SILLS. RUNNING THENCE N.  $3\frac{1}{2}^{\circ}$  ( THREE AND ONE HALF DEGREES ) E. 440.3 FEET. THENCE N.  $86\frac{1}{2}^{\circ}$  W. 158.4 FT. THENCE S  $3\frac{1}{2}^{\circ}$  W. 138.3 FEET. THENCE SOUTH  $86\frac{1}{2}^{\circ}$  E. 158.4 FEET TO THE BEGINNING CONTAINING 1.(ONE) AND .597 (FIVE HUNDRED AND NINETY SEVEN THOUSANTHS ACRES.

I LAID OUT SAID PIECE OF LAND IN LOTS AND ALLEYS IN FORM AND SIZE AS DELINEATED ON THE ACCOMPANYING PLAT. THE DISTANCES ARE GIVEN IN FEET AND DECIMALS AND ARE MARKED IN BLACK INK ON OR NEAR THE LINES OR SPACE TO WHICH THEY REFER. THE NUMBER OF EACH LOT IS MARKED ON IS CORRESPONDING LOT. THEREBY CERTIFY THAT THE ACCOMPANYING PLAT IS A TRUE REPRESENTATION OF SAID SURVEY.
