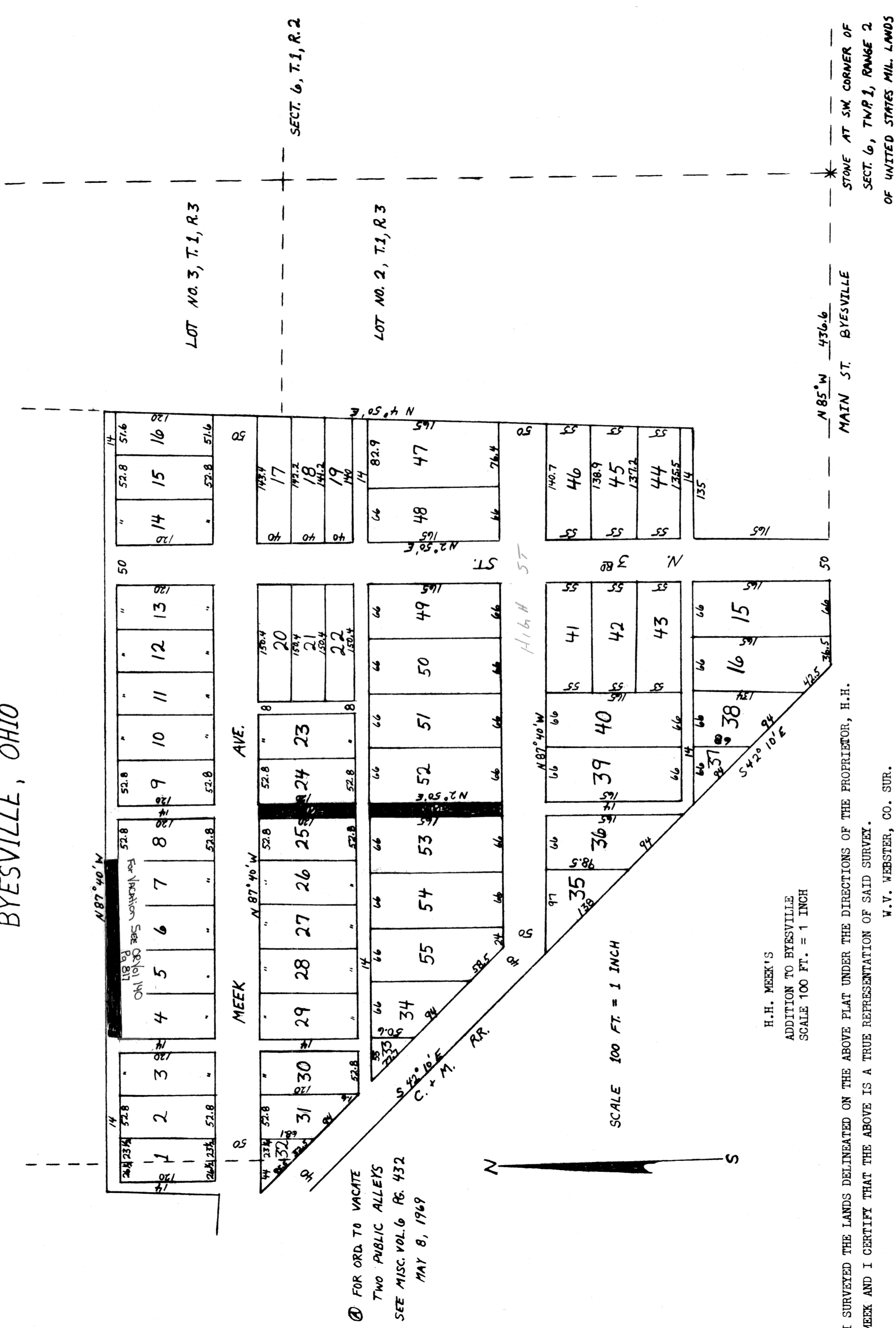


H.H. MEEK'S ADDITION TO BYESVILLE, OHIO
