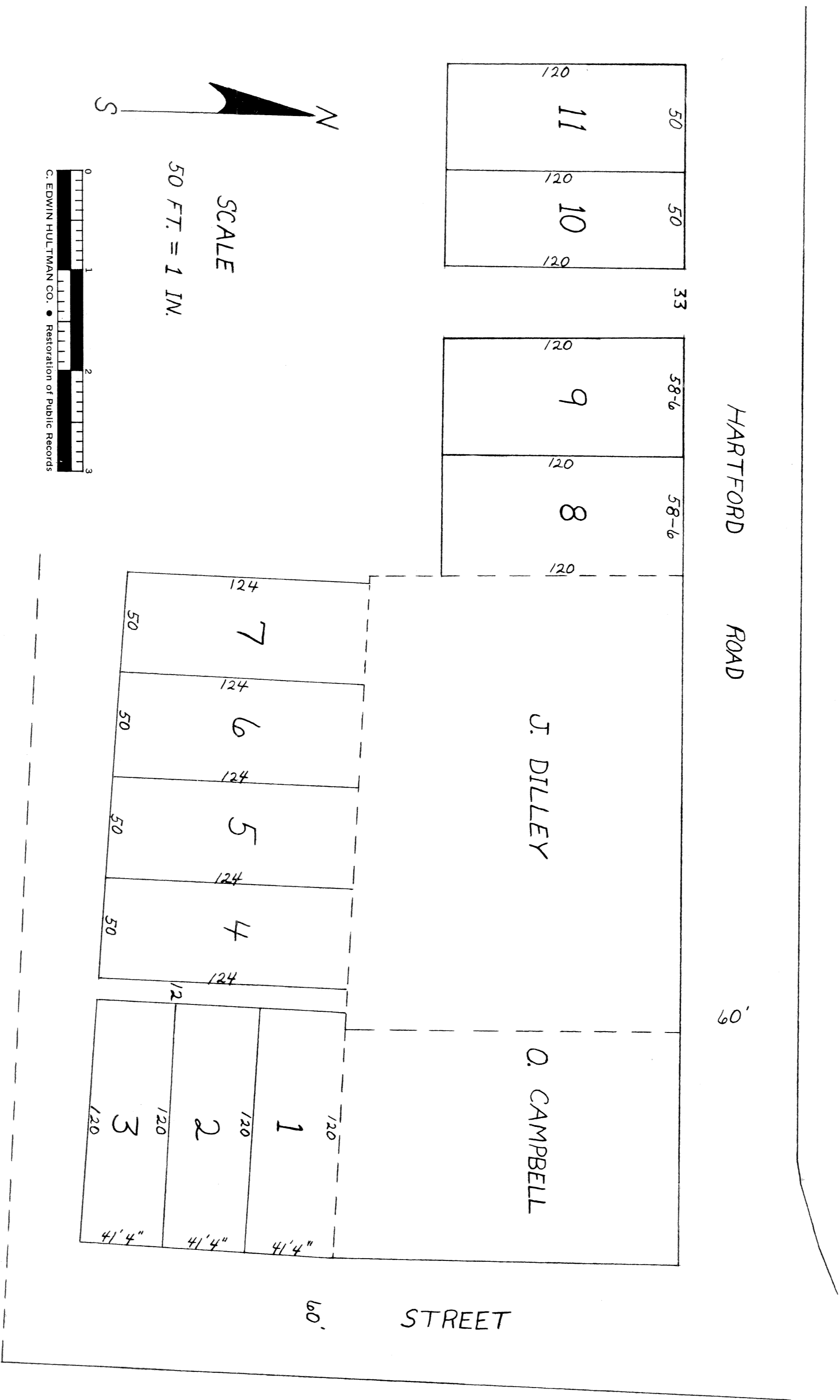


CAMPBELL'S ADDITION TO SENECAVILLE, OHIO
