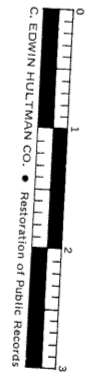
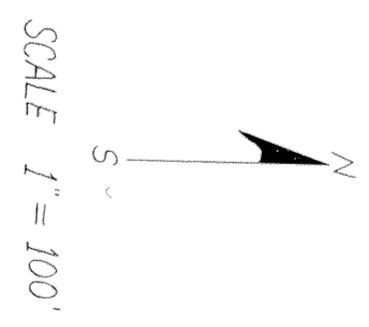


# OAKLAND PLACE ADDITION TO CAMBRIDGE, OHIO

I HEREBY CERTIFY THAT THE ABOVE PLAT OF "OAKLAND PLACE" ADDITION TO THE CITY OF CAMBRIDGE, GREENSBERG COUNTY, OHIO, AS SURVEYED BY ME UNDER THE DIRECTION OF THE PROPRIETOR, THE CAMBRIDGE LAND AND DEVELOPMENT COMPANY, TO BE CORRECT; THAT THE CORRELATION LINES OF SAID CITY IS SHOWN IN SAID PLAT, IN RED INK, AND THE LOTS, PARTS OF LOTS, ROADS, HIGHWAYS, STREETS, AND ALLEYS LYING WEST AND SOUTH OF SAID CORRELATION LINE ARE WITHIN THE CORRELATED LIMITS OF SAID CITY; THAT THE SPACES INDICATED BY THE YELLOW COLORING ARE FOR PARKING, AND ARE NOT TO BE BILLED UPON; THAT THE PARKING ON ALL THE STREETS RUNNING IN A NORTH AND SOUTH DIRECTION IS TWENTY FEET WIDE, AND ON ALL THE STREETS RUNNING IN AN EAST AND WEST DIRECTION IS FIFTEEN FEET WIDE; THAT THE PARKING APPLIES TO ALL LOTS EXCEPTING LOTS NUMBERS ONE TO TWENTY INCLUSIVE, THE LANDS DELINEATED ON SAID PLAT ARE SITUATE IN THE NORTH QUARTER OF TOWNSHIP TWO AND RANGE THREE IN GREENSBERG COUNTY, OHIO, BEING THE LANDS COVERED BY A.W. CLARK, ET AL., TO T.W. SCOTT, TRUSTEE, AND BY SAID TRUSTEE TO SAID THE CAMBRIDGE LAND AND DEVELOPMENT COMPANY, BY DEED DATED APR. 10, 1907, AND RECORDED IN VOL. 93, AT PAGE 20, OF THE RECORDS OF DEEDS OF GREENSBERG COUNTY, OHIO.
