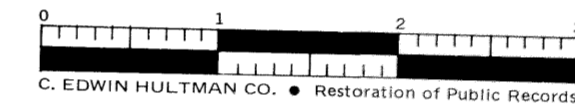
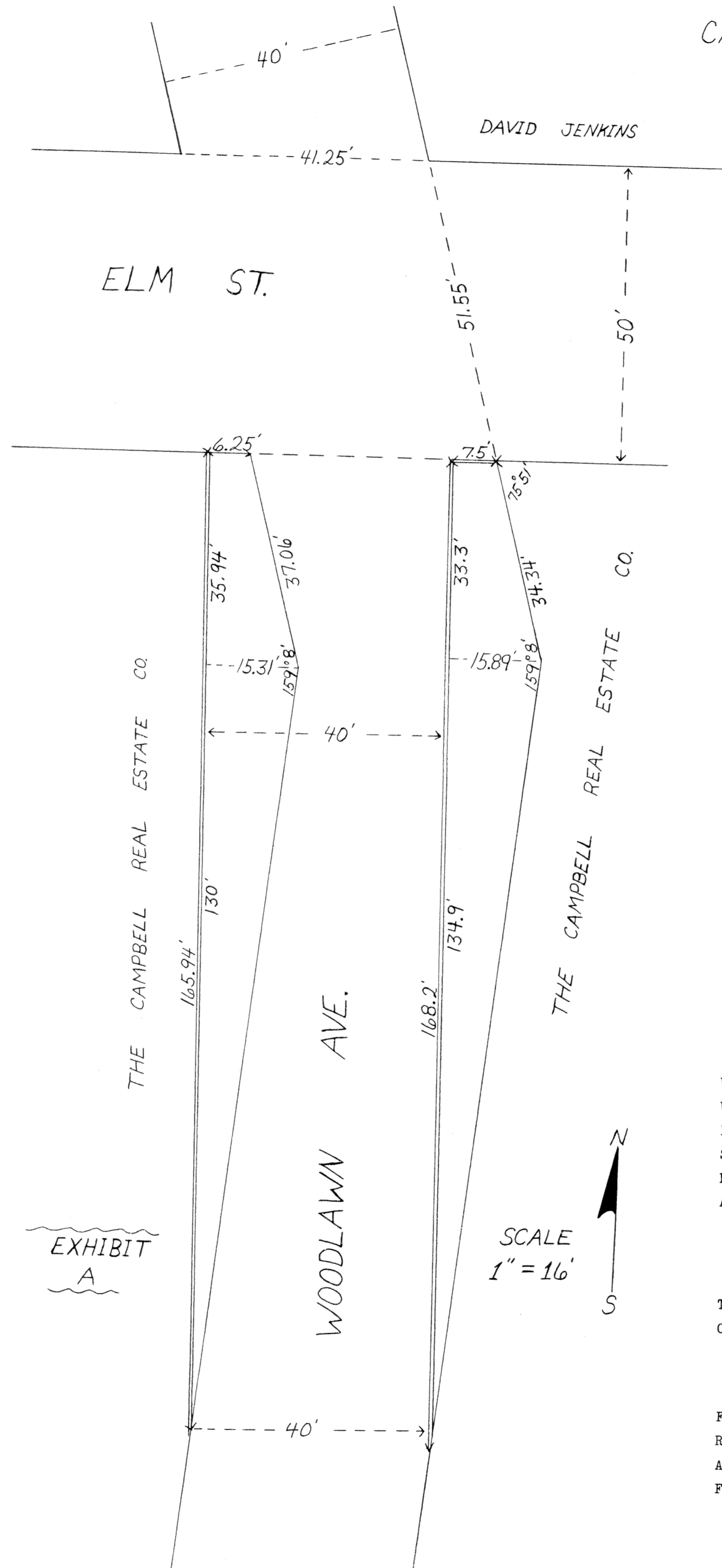

TO THE COUNCIL OF THE CITY OF CAMBRIDGE, STATE OF OHIO:

GENTLEMEN: THE UNDERSIGNED, BEING THE OWNERS OF ALL THE LOTS AND LANDS IN SAID CITY OF CAMBRIDGE ABUTTING AND FRONTING UPON THAT PART OF WOODLAWN AVENUE IN SAID CITY HEREINAFTER DESCRIBED, RESPECTFULLY PETITION YOUR HONORABLE BODY THAT A PART OF SAID WOODLAWN AVENUE IN SAID CITY BE VACATED, SAID PART SO TO BE VACATED BEING PARTICULARLY DESCRIBED AS FOLLOWS, TO WIT: BEGINNING ON THE EAST LINE OF SAID WOODLAWN AVENUE FIFTY-ONE 55/100 FEET SOUTHWARD ALONG SAID EAST LINE FROM THE SOUTHWEST CORNER OF THE PREMISES FRONTING ON SAID AVENUE OWNED BY DAVID JENKINS; RUNNING THENCE AT AN ANGLE OF 75 DEGREES 51 MINUTES WITH SAID EAST LINE WEST SEVEN AND ONE-HALF FEET; RUNNING THENCE AT RIGHT ANGLES WITH SAID LAST MENTIONED LINE SOUTHWARD ABOUT 168 2/10 FEET TO THE INTERSECTION THEREOF WITH SAID EAST LINE OF SAID WOODLAWN AVENUE NORTHEASTWARD AND NORTHWESTWARD WITH ITS MEANDERINGS TO THE BEGINNING. UPON THE VACATION OF SAID PART OF SAID STREET BEING DULY ACCOMPLISHED THE UNDERSIGNED THE CAMPBELL REAL ESTATE COMPANY, AS SHOWN THEREOF, WILL CONVEY TO SAID CITY, FOR STREET PURPOSES, AS PART OF SAID WOODLAWN AVENUE, A CORRESPONDING PORTION OF ITS PREMISES ABUTTING AND FRONTING UPON THE WEST SIDE OF SAID WOODLAWN AVENUE SO AS TO STRAIGHTEN SAID PART OF SAID AVENUE AND MAKE SAID PART OF THE UNIFORM WIDTH OF FORTY FEET.
