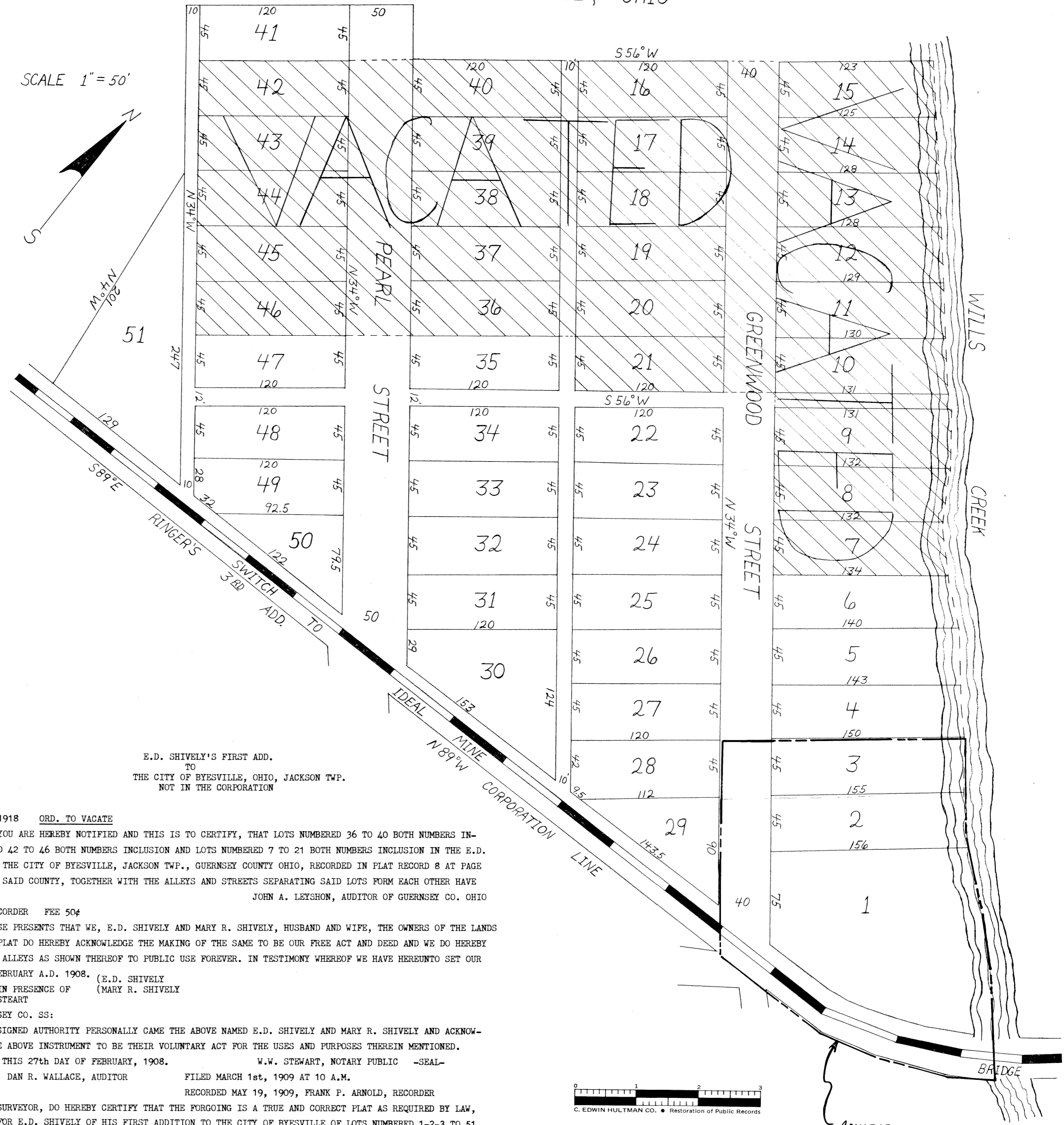

CLUSION AND LOTS NUMBERED 42 TO 46 BOTH NUMBERS INCLUSION AND LOTS NUMBERED 7 TO 21 BOTH NUMBERS INCLUSION IN THE E.D.  
SHIVELY'S FIRST ADD. TO THE CITY OF BYESVILLE, JACKSON TWP., GUERNSEY COUNTY OHIO, RECORDED IN PLAT RECORD 8 AT PAGE  
45 OF THE PLAT RECORD OF SAID COUNTY, TOGETHER WITH THE ALLEYS AND STREETS SEPARATING SAID LOTS FORM EACH OTHER HAVE
