


# SALESVILLE

Johnson. thence south with the east line of lot owned by J.W. Commissioners Met at Salesville as per adjournment of Aug. 20th 1878  
 The petition of W.C. Rose, W.D. Beeks & others, praying the commissioners for incorporation of the Village of Salesville Gue Co. Ohio. In the consideration of said petition. W.C. Rose & W.D. Beeks being first duly sworn. deposes & says, that 41 said signers to said Petition are legal voters residing in said territory to be incorporated. W.C. Rose & W.D. Beeks also state that they know the said boundaries as described for said incorporation & there are more than 50 legal voters, & more than 200 inhabitants in said territory. Board then adjourned to meet at Cambridge Ohio. on Aug. 28rd. 1878  
 Cambridge Ohio Aug. 28rd. 1878. Commissioners Office. Board met in Special session all being present. on motion of Mr. Sochary. the Petition that W.C. Rose & W.D. Beeks & others was taken up & finally disposed of as follows. the prayer of the petitioners was granted & the incorporation of the town of Salesville to be as specified in the accompanying plat. & ordered to be placed on Journal of Commissioners and that the Auditor make a correct transcript of the Commissioners & the case to be filed with the County Rec. together with the papers in the case

asking for the incorporation. of said Village with the following bounds "to wit" beginning for the same at a point on the southside of the B & O R.R. opposite the SE. cor of a lot of land owned by Eli Brill. thence. along the south line of said R.R. to the point opposite the alley. east of lot No 27 thence due west. to the west line of a 3 acre lot. of land south of said R.R. owned by Thos Mendenhall. Thence due north to the south line of said R.R. thence westerly along the south line of same to the bridge on the stone pike over said R.R. Thence due North. to the SW cor of Jane Brill's land. thence due east. to west line of lands. owned by James R. Johnson. thence south with east line of lot. owned by J.W. White to the north line of the Clay. Pike. thence with the north line of same east to a point opposite the N.E. cor. of Eli Brill's lot aforesaid. & thence to the place of beginning
