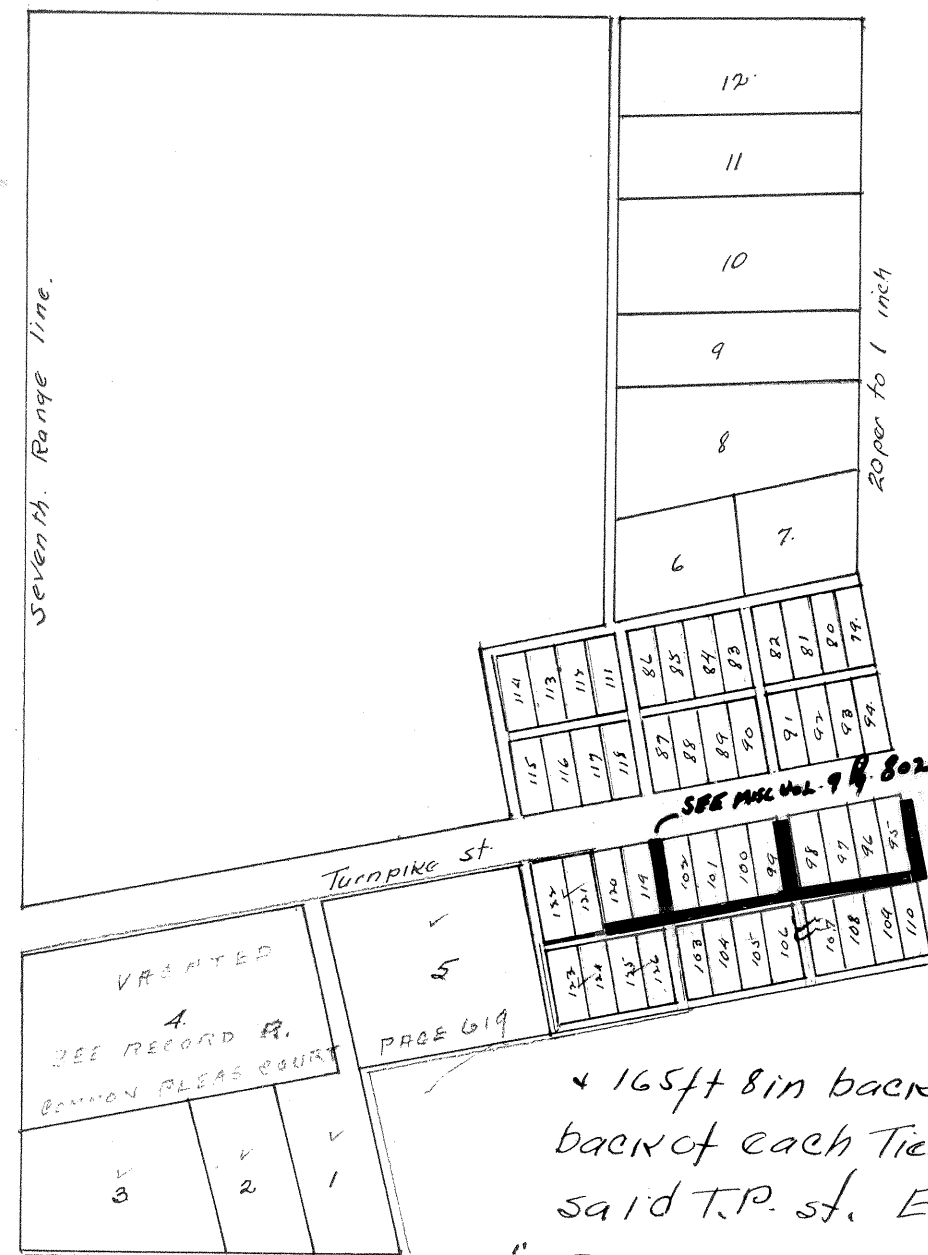
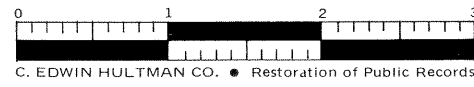


ADDITION TO MIDDLETOWN



Surveyed in addition to Middletown as follows. situate & adjoining the west end of said Middletown & adjoining the alley bounding the first made by John Stewart. No 15-14-49-50 which may be seen on the original survey of said town. 16 lots lying on the north of the street called Turnpike st. & 16 lying south of said street as may be seen in the above Plat of said addition to Middletown, beginning with the survey at the S.E. cor. of a front lot No 94. on the north side of Turn Pike St parallel with said St. which bears S. 79° W. & at right angles with N 11° W. commencing with the numbering of said lots to said addition in a back lot North of said Turnpike St. and adjoining the alley on the first survey with No 79. Then progressing to 110 in a back lot south of said T.P. st. also addition to the addition of Middletown on the west end of said addition and adjoining the alley bounding lots 86-87-102-103. which may be seen on the above plat of said addition to said Middletown. 8 lots lying on the north of T.P. st. & 8 lots on the south side of said st. which lead the same course and parallel. the lots in said addition to said Middletown. Commencing with No 111. opposite 86. & progressing to No 126. opposite 103. which may be seen in the above Plat. All the lots on the north side of T.P. st. contain 40.2 per. 66ft 4in in front & 165ft. back. All the lots on the south side of said st of an equal size 40.6 sq per. 66ft 4in in front & 165ft 8in back. An alley between every 4 lots at right angles with turnpike St. Alley on the back of each tier of front lots. Alleys on the extreme of both tiers of Back lots. & running parallel with said T.P. st. Each alley 16 1/2 ft wide
