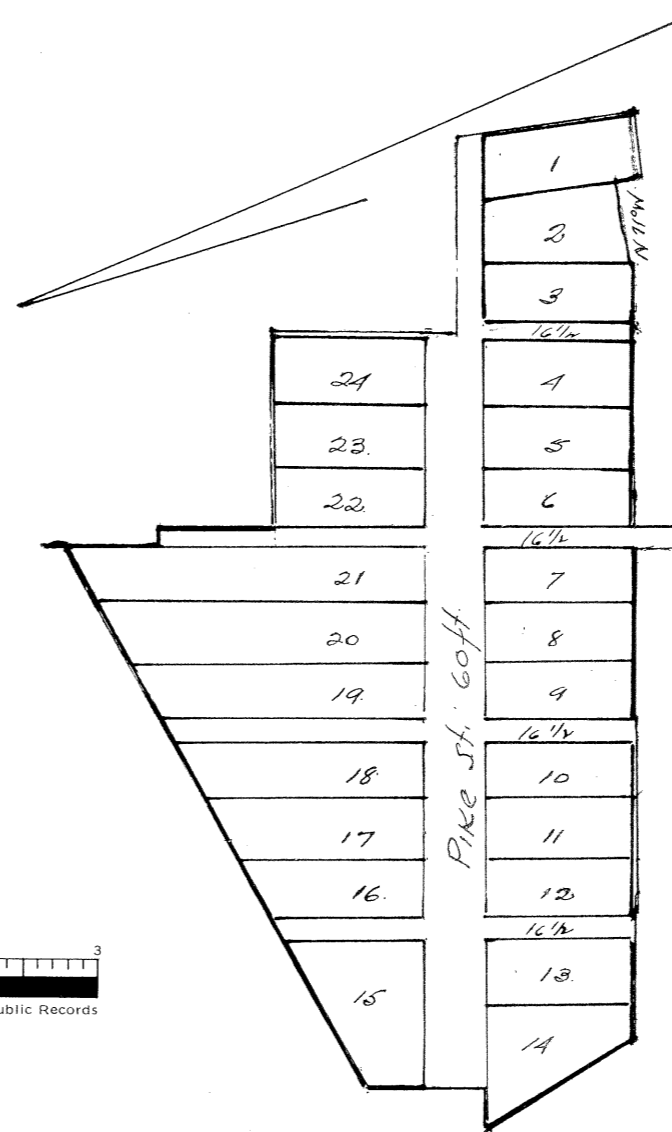
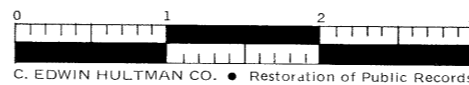


# NEW GOTTENGEN

Plat of New Gottengen laid out Mr Chas Haedelbach on the clay pike on the lands known as the Hammond Tract south of the Leatherwood forks of Wills creek Richland Twp Que. Co O. May 13<sup>th</sup> AD 1836 beginning for said town at a stone at the N.E. cor of lot No 1. fronting with the street N 68° W at right angles with N 25° E. 4 per in front & 10 back. containing 40.59 per. lot No 2. fronts with st. N 60° W 4 per the line between No 1 & 2. S 22° E 9 per. between No 2 & 3. S 30° W 10 per. back end of No 2. N 71° W. 5.28 per. contains 47.59 per. lots No 3-4-5-6-7-8-9-10-11-12-13. 22-23-24. bearing in N 60° W at right angles with N 30° E. 4 per in front by 10 back. contains 40.59 per. lot No 14. bearing in front N 60° W 7.68 per. South 11.56 per with the widow Roby line back part same angle with front 2 per. the line with No 13. the same angle & distance with said No 13. containing 18.45 per. lot No 15 front N 60° W 9.68 per. at right angles N 30° E 3.44 per. westerly line easterly line N 30° E. 8.92 per. back line S 89 1/2° E. 11.16 per. contains 59.82 sq per. lot No 16 front N 60° W 4 per west line N 30° E. 9.50 per.
