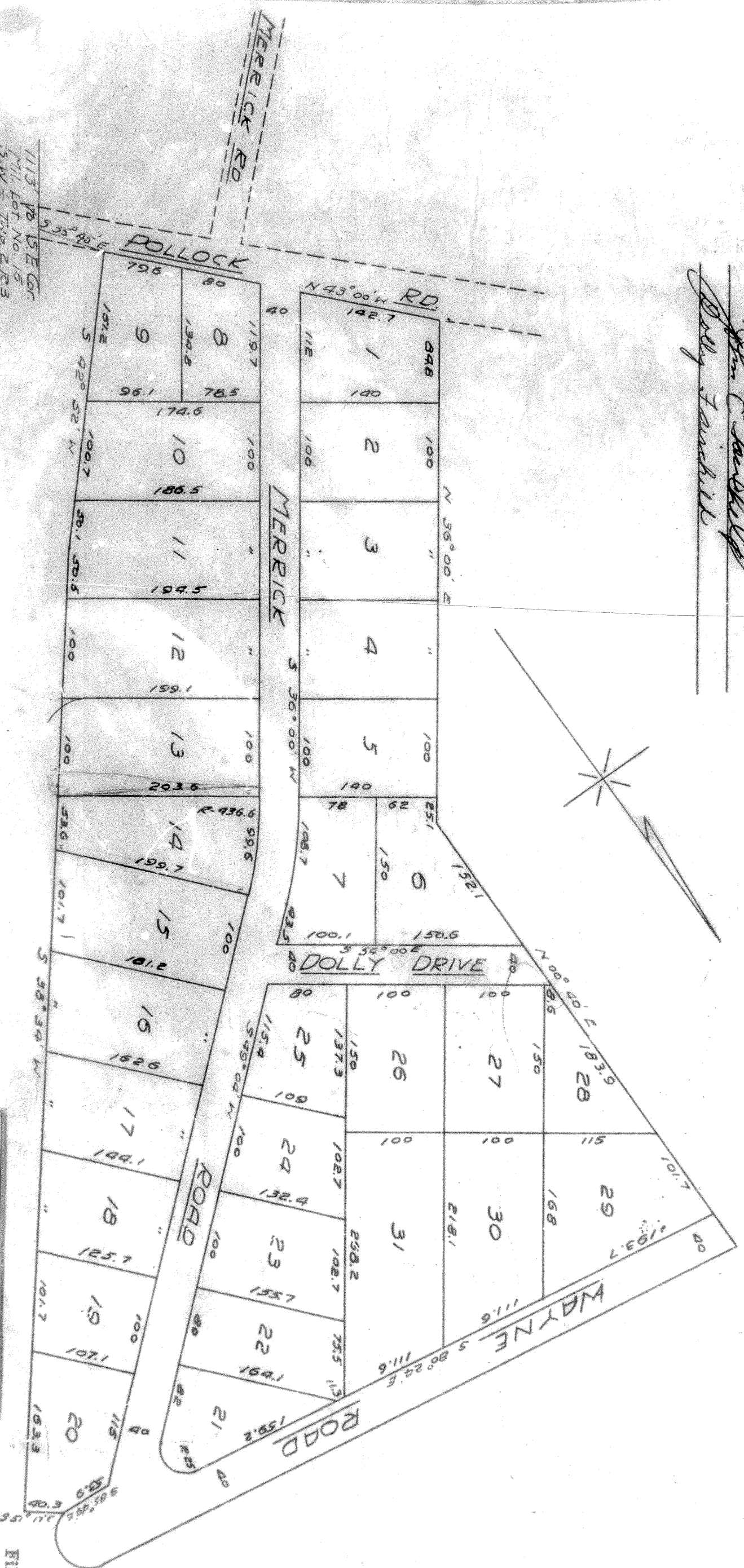
DEDICATION

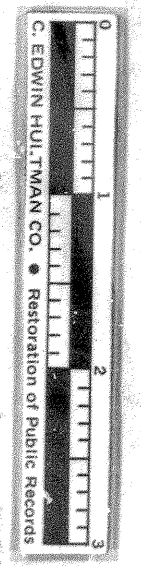
