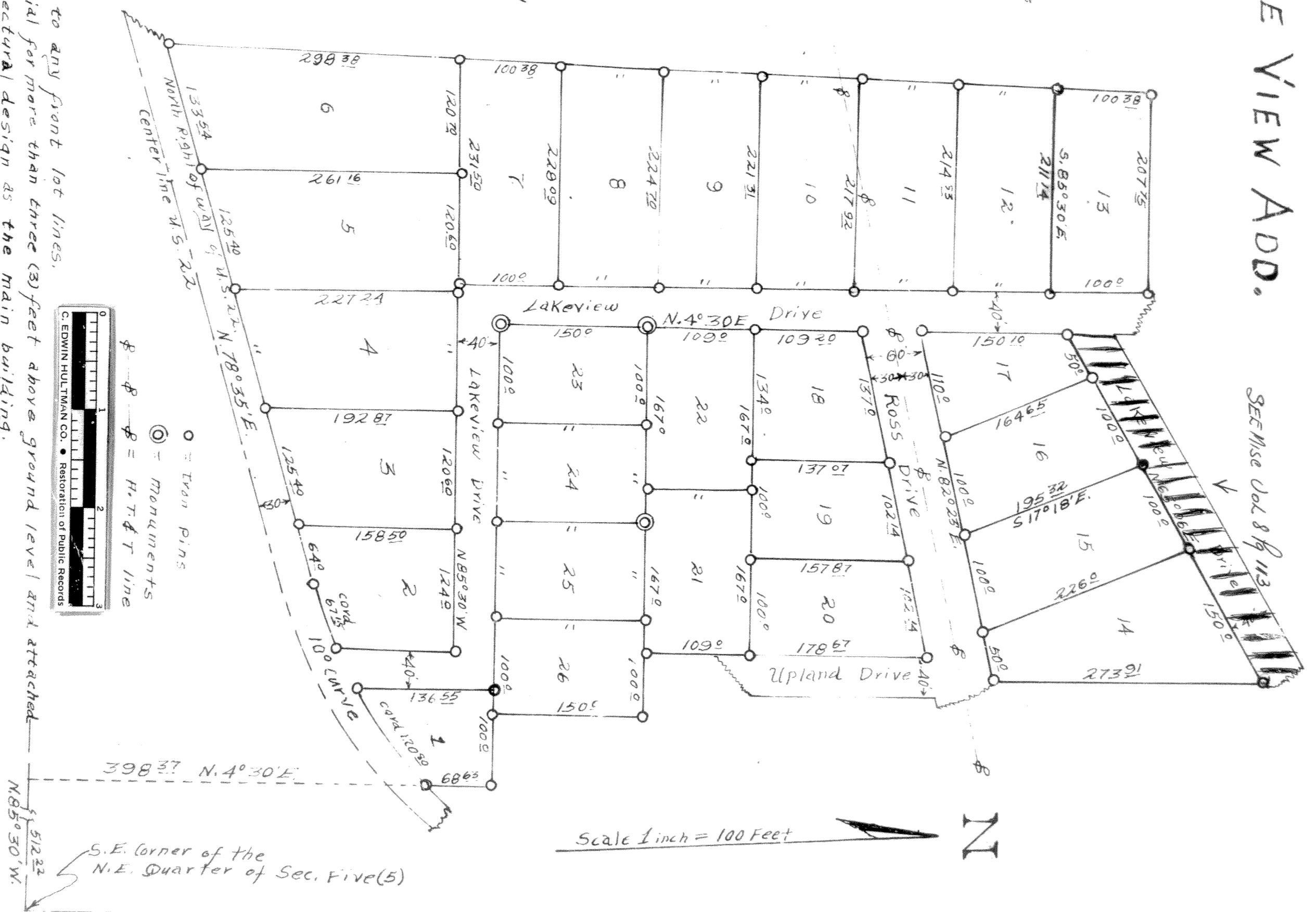

### RESTRICTIONS

- 1 No building shall be built closer than twenty-five (25) feet to any front lot lines.
- 2 No building shall be erected of cement block or similar material for more than three (3) feet above ground level and attached garages or out buildings shall be of the same architectural design as the main building.
- 3 All residences shall be of not less than one thousand one hundred (1100) square feet of living area exclusive of garages, porches or breezeways.
- 4 All lots and buildings shall be used exclusively for residential purposes and there shall not be more than one such building on each lot.
- 5 No trailers or trailer courts are permitted on the premises.
- 6 All septic tanks and sewer systems must comply with the standards as prescribed by the Guernsey County Board of Health.
- 7 Portions of lots specified herein are subject to a perpetual easement for the installation, repair, and maintenance of water, gas, electric, and sewer lines; said easement shall extend 15 feet in width across the east end of lots 7, 8, 9, 10, 11, 12 and 13; said easement shall extend 10 feet in width across the north end of lots 5 and 6; said easement shall extend 10 feet in width across the north end of lots 23, 24, 25 and 26; said easement shall extend 5 feet in width across the north side of lots 1 and 2; said easement shall extend 10 feet across the south side of lots 7, 19, 19 and 20; said easement shall extend 5 feet across the south side of said 21 and 22. No buildings of any type are to be erected on any portion of lots which are subject to said easement.
