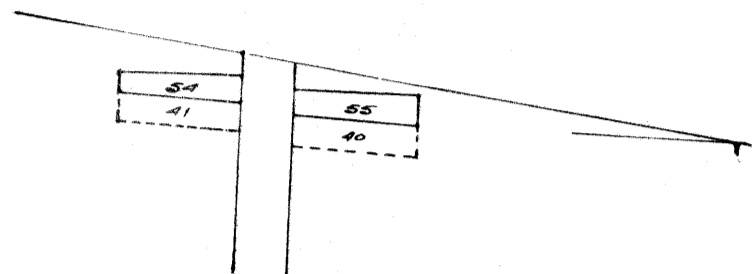


J. SMITH ADD. TO MILLWOOD



Lot No 55 of the new Addition lies immediately west of lot No. 40 of the original town & is described as follows, commencing at the N.W. cor of lot No 40 thence S 82° W 36.20 ft thence S 0.20° E 10 per. thence N 82° E 40 ft. thence along the west line of lot No 40 to the place of beginning. 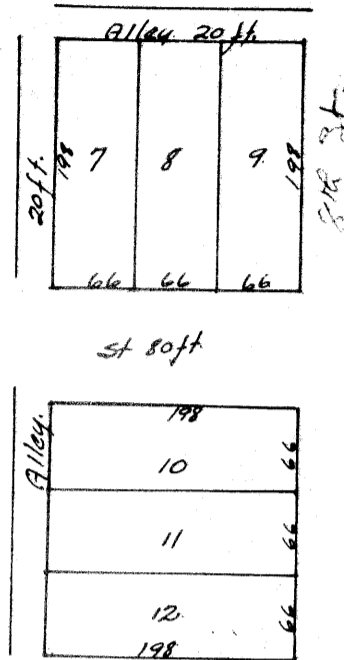

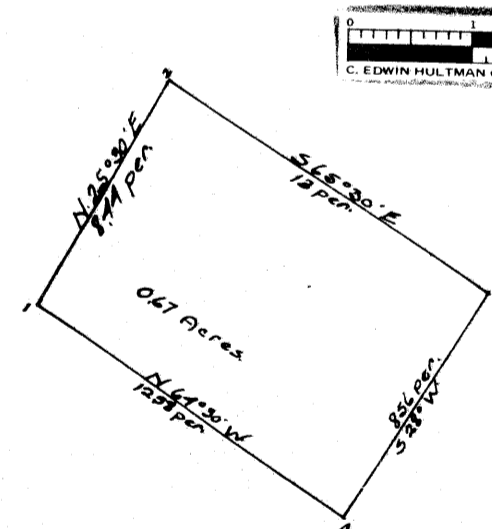
E. TINGLE 2ND. ADD. TO CAMBRIDGE
