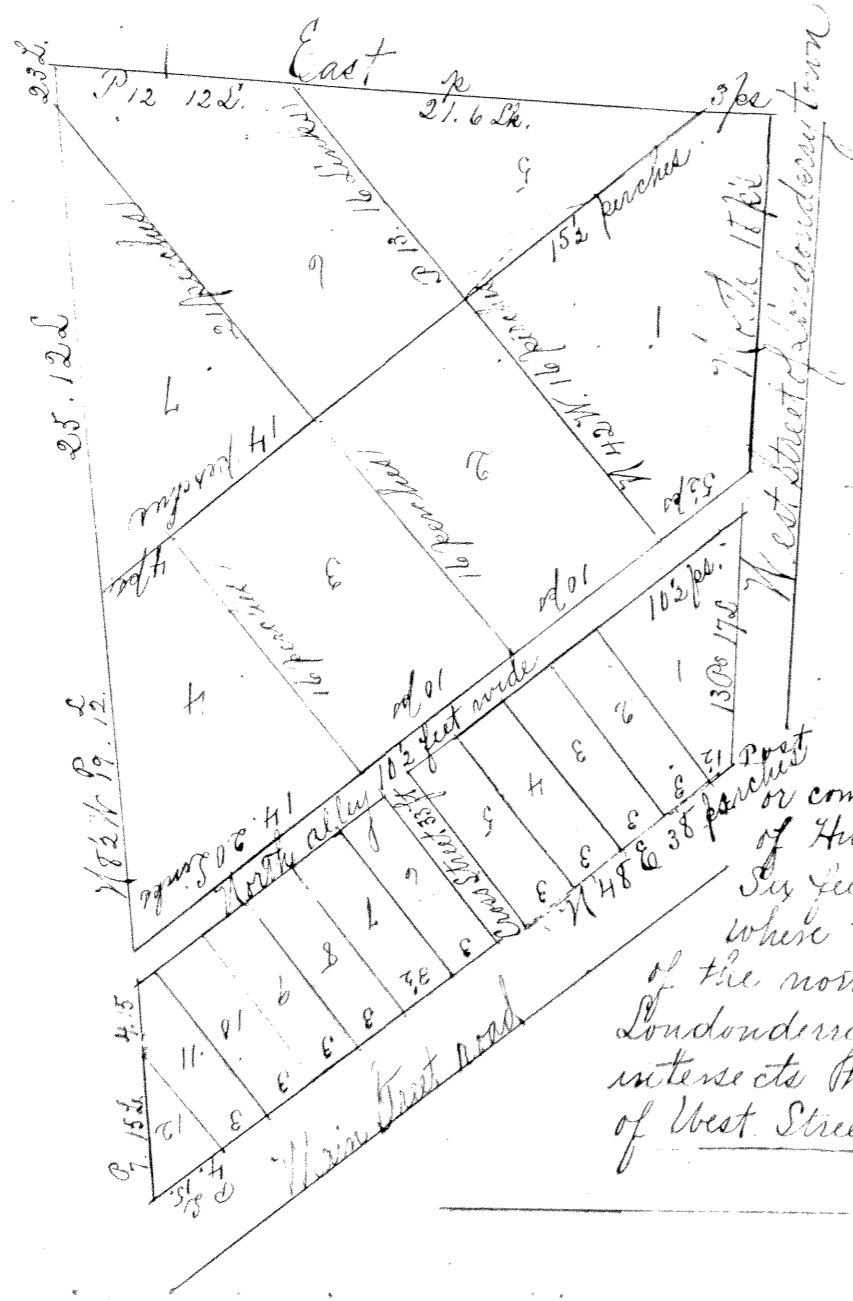


Londonderry Customs Addition



Plot of Huston's Addition to the Town of Londonderry in the County of Kerry and State of New York, laid out by James Huston's proprietor.

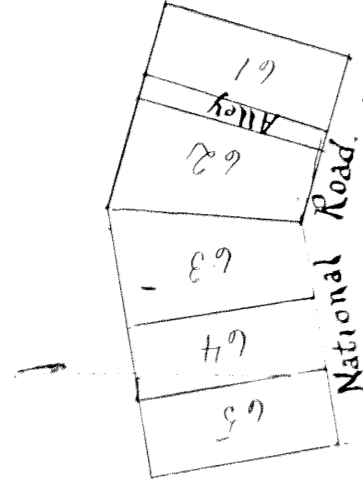
Specifying the Main Street runs N 41° E. An alley runs parallel to Main Street and is 10 feet wide. Cross Street is 33 feet wide and runs N 42° W from Main Street. The lots run parallel with Cross Street. Each lot contains 30 perches except lot No. 1, 11, 12. Lot No. 1 contains one rood + 30 perches. Lot No. 11 contains 26 perches. Lot No. 12 contains 13 1/2 perches. Back lot No. 1 contains one acre. Lot No. 10 contains one acre + 82 perches. Lot No. 3 contains one acre. Lot No. 4 contains one acre + 82 perches. Lot No. 5 contains 2 roods and 37 perches. Lot No. 6 contains one acre, one rood + 27 perches + back lot. Lot No. 7 contains three roods + 27 perches.

Addition to Garrison



June 11th 1831 Surveyed an Addition to the town of Garrison north side of the National Road and adjoining the west end of said Garrison, beginning for said Addition at the north west corner of Lot No. 16 in plat of said town (old plat) lot No. 61 in the annexed plat east of an alley lot No. 62 and 63. Contains each of them 52 1/2 square perches. The line dividing said lots 62 + 63 bears N 6. E. distance and 17 1/2 rods. Lot No. 62 bears in front S 82° W and each 4 perches. Lot and west side of 61 and east side of 62 bears N 47° E 16 feet 16 1/2 feet the line dividing 62 + 63 has a perpendicular distance 64 feet bears in front S 82° W and each 4 perches.
