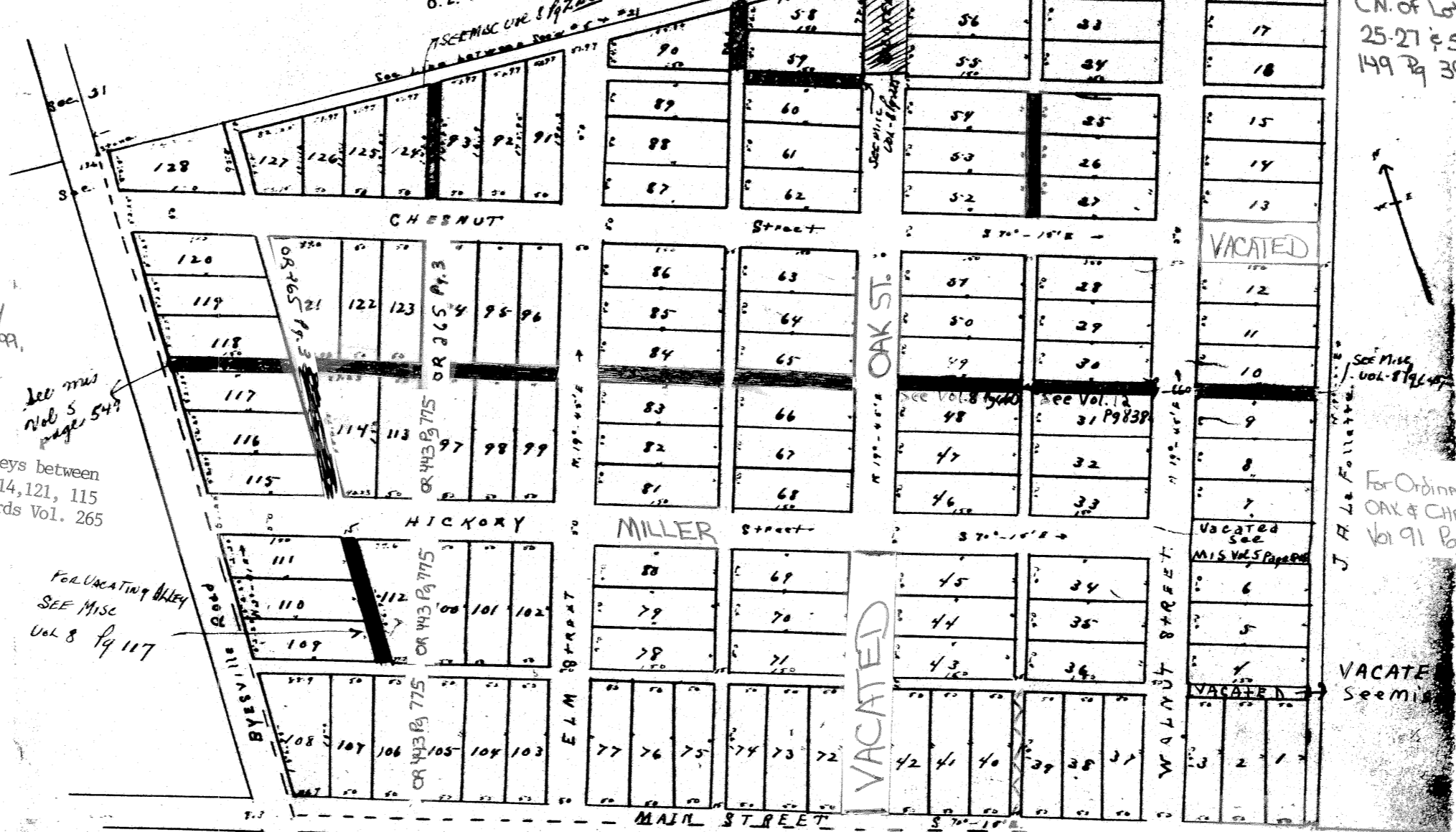


PLAT OF J. A. LA FOLLETTE'S
