

A TRUE PLAT OF THE NEW ADDITION TO THE SOUTH END OF THE TOWN OF LIBERTY, GUE. CO. OHIO. BEGINNING AT A STONE PLANTED IN THE S.E. COR. OF THE PUBLIC SQUARE, FROM THENCE S 8°30'W 30 PERCHES. THENCE N 82½°W 10 PERCHES. THENCE N 8½°E 34 PER. THENCE S 82½°E 12 PER. INCLUDING MAIN STREET. THENCE S 8½°W 34 PER. THENCE S 82½°E 10 PER. THENCE N 8½°E, 34 PER. THENCE N 82½°W 10 PER. 



PLAT OF ADDITION TO LIBERTY

TO THE PLACE OF BEGINNING CONTAINING 15 LOTS, CONTAINING ¼ ACRE EACH. THE REMAINDER TWO LOTS ARE FRACTIONS AS FOLLOWS. LOT NO 1, 55 PERCHES, LOT NO. 10, 35 PERCHES & 1.65 FT. THE WHOLE STREETS, ALLEYS AND LOTS CONTAIN 6 ACRE, 2 RODS, 36 PERCHES OF LAND. THIS ADDITION TO THE N.W. CORNER OF THE TOWN OF LIBERTY. IT BEING IN THE WEST HALF OF THE EAST HALF OF SEC. 23, TWP. 4 & R. 3.
