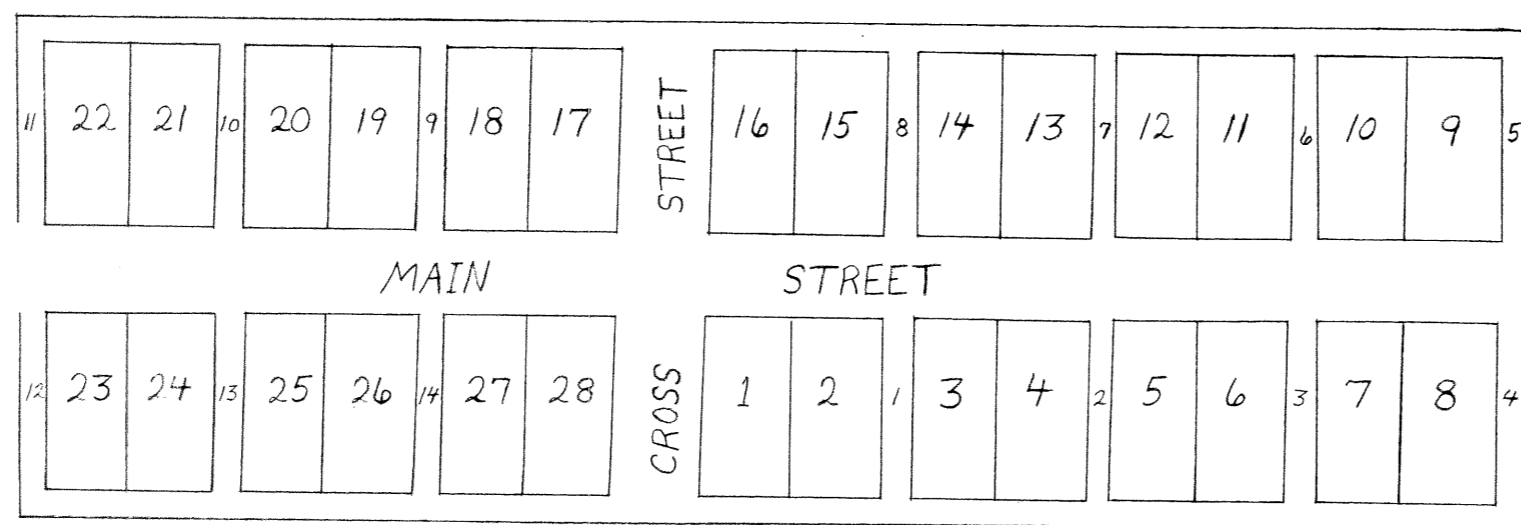

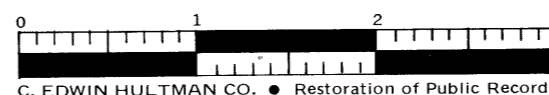

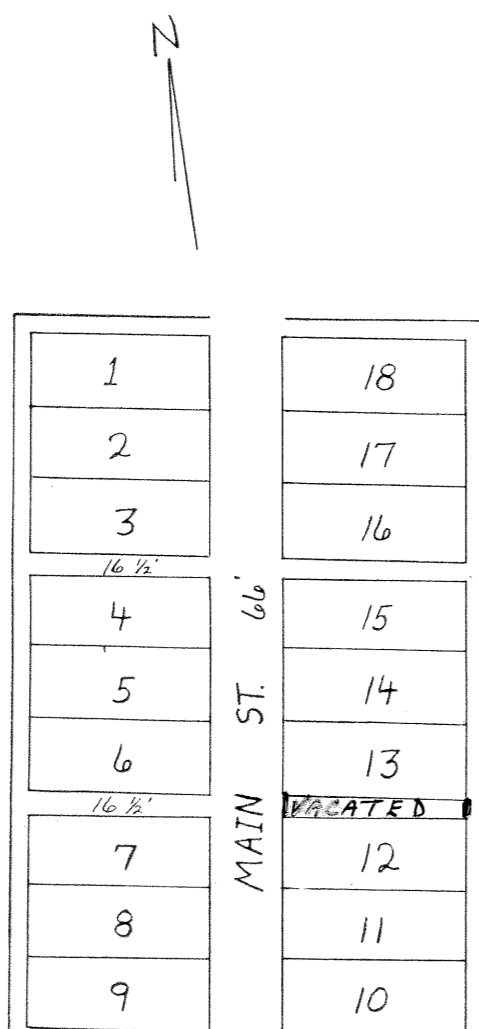

PLAT OF HOSSACK'S ADDITION NEW SALEM



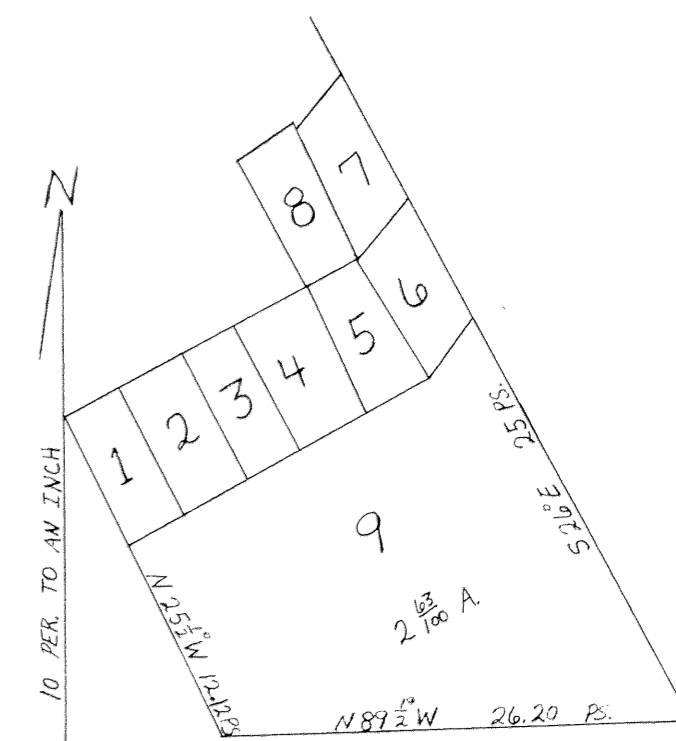
