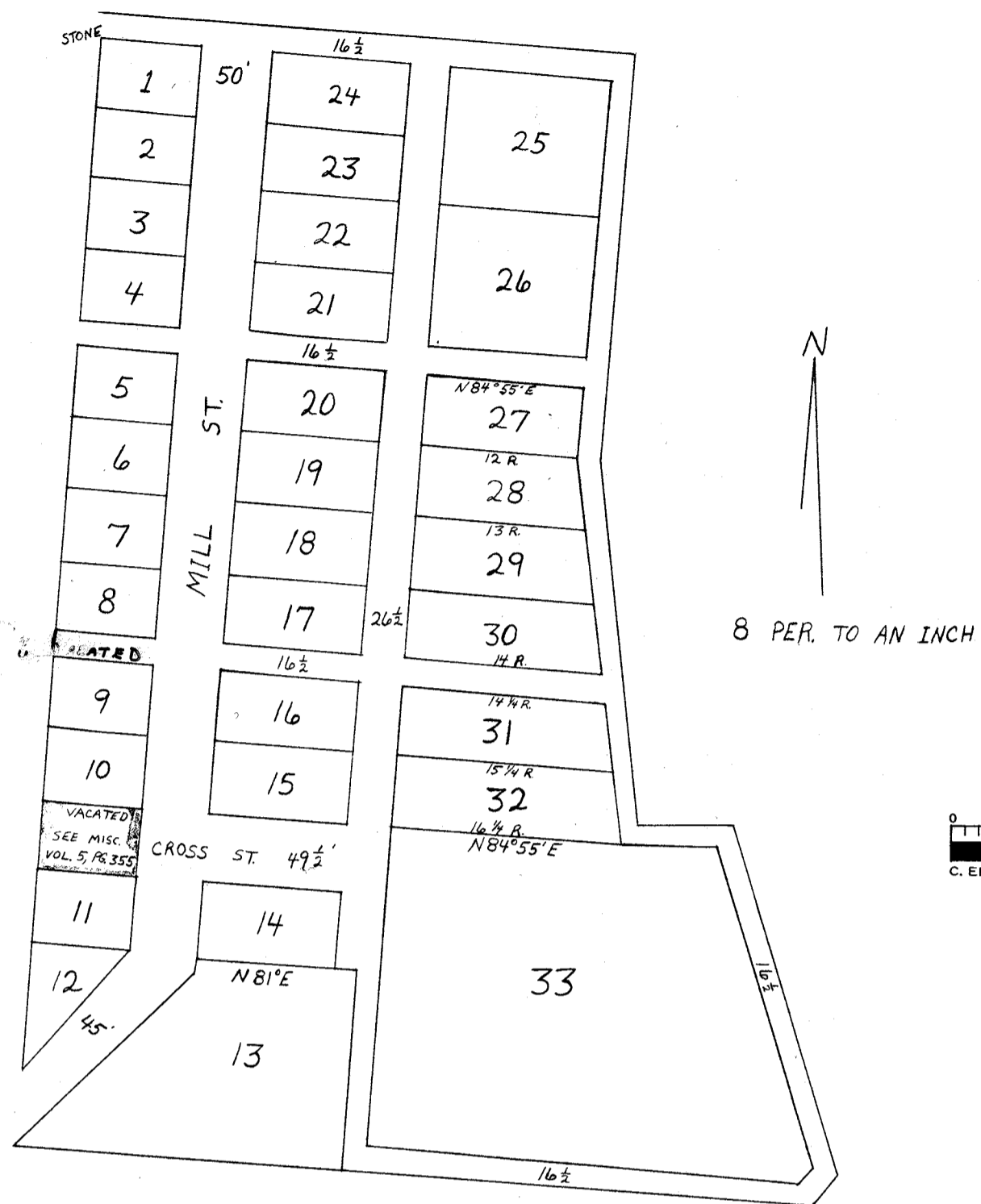


SECOND ADDITION TO SENECAVILLE



2nd ADDITION TO SENECAVILLE

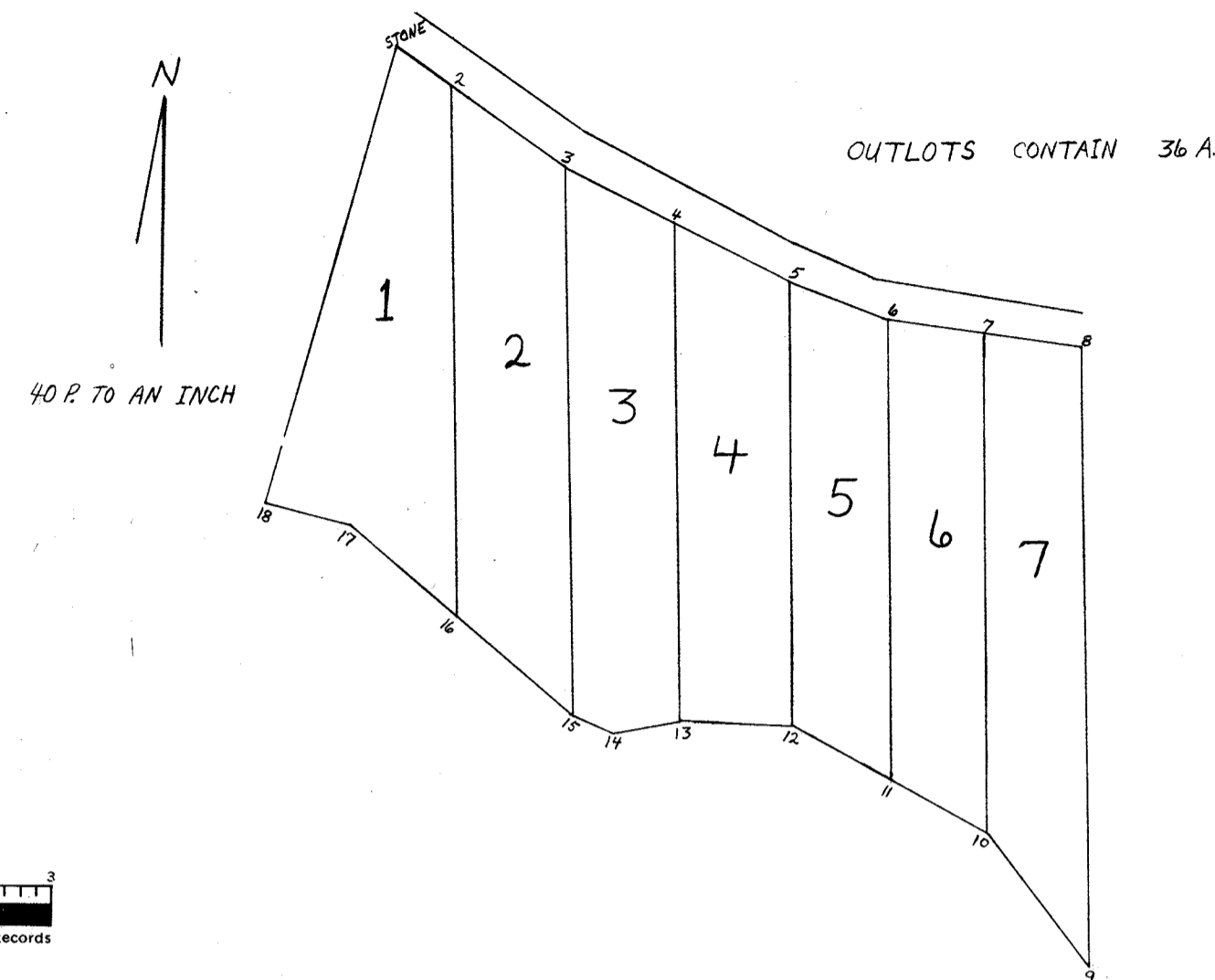
LOT NO. 1 COMMENCES AT THE SOUTH SIDE OF THE STONE NUMBERED ONE RUNS N 84°55'E. 6 RODS & 2 LINKS. THENCE S 9°E 58' TO THE N.E. COR. OF LOT NO. 2, AND WITH THE ORDER OF THE REST OF THE LINES CONTAINS 22.5 RODS. LOT NO. 24 IS 54 FT. WIDE & ON THE EAST IS 45.6" WIDE & RUNS THE CORSE GIVEN ON THE PLAT CONTAINS 22 PERCHES. IN LOTS CONTAIN 10.5 ACRES & 31 RODS OF LAND STREETS & ALLEYS 2 1/2 ACRES & 3 RODS OF LAND.

PLAT OF THE SECOND ADDITION TO SENECAVILLE IN RICHLAND TWP. GUE. CO. OHIO SITUATED ON THE WEST HALF OF SEC. 21, TWP. 1 & R. 2, LOTS 2,3,4,5,6,7,8,9,10 & 11 FRONT ON STREET 4 RODS. EACH & RUN BACK 6 RODS. EACH OF THE ABOVE LOTS CONTAIN 24 RODS. LOTS 14,15,16,17,18,19,20, 21,22 & 23 FRONT ON THE EAST SIDE OF STREET, EACH 4 RODS & RUN BACK 8 RODS CONTAINING 32 RODS OF LAND, LOTS 25 & 26 EACH FRONT ON ST. 8 RODS & RUN BACK 11 RODS & CONTAIN 88 RODS LOT NO. 27 FRONTS ON THE SAME ST. 4 PER. & BACK 11 PER., LOTS 28, 29,30,31,32 EACH FRONT ON THE SAME ST. 4 PERCHES, THE DISTANCE THEY EACH RUN BACK IN GIVEN ON THE LINE OF THE PLAT. AND ALSO THE AMOUNT THEY EACH CONTAIN.

LOT NO. 33, COMMENCES AT THE S.W. COR. OF LOT NO. 32 & RUNS N 84°55'E. 20 1/2 PER, THENCE S. 42°E. 20 PER. THENCE S 17°W 1 ROD & 17 LINKS THENCE S 83 1/2°W. 29 RODS & 18 LINKS THENCE N 9°W. 14 RODS & 21 LINKS TO THE PLACE OF BEGINNING, CONTAINING 2 ACRES & 119 RODS OF LAND. LOT NO. 13 COMMENCES AT THE S.W. COR. OF LOT NO. 14 RUNNING N 81°E. 9 RODS & 15 LINKS THENCE S.9°E. 10.5 RODS, THENCE S 83 1/2°W 19 RODS & 19 LINKS, THENCE N 36 3/4°E 13 RODS & 22 LINKS TO THE PLACE OF BEGINNING CONTAINING 152 SQ. PER. LOT NO. 12, BEGINS AT THE N.W. CORNER OF LOT NO. 11, THENCE RUNS N 81°E 6 RODS THENCE S 36 3/4°W. 10 RODS & 9 LINKS, THENCE N 9°W. 7 RODS & 11 LINKS TO THE BEGINNING CONTAINS 22.5 RODS. STREETS BEAR S. 9°E. BY N 9°W TO THE S.E. COR. OF LOT NO. 11 BEING 50 FT. WIDE FROM THENCE IT BEARS S 36 3/4°W 45 FT. WIDE. STREET RUNS PARELELL TO THE STREET ABOVE NAMED, TO THE S.E. COR. OF LOT NO. 14 AND IS 26 1/2 FT. WIDE. CROSS STREETS IS 3 RODS WIDE.
