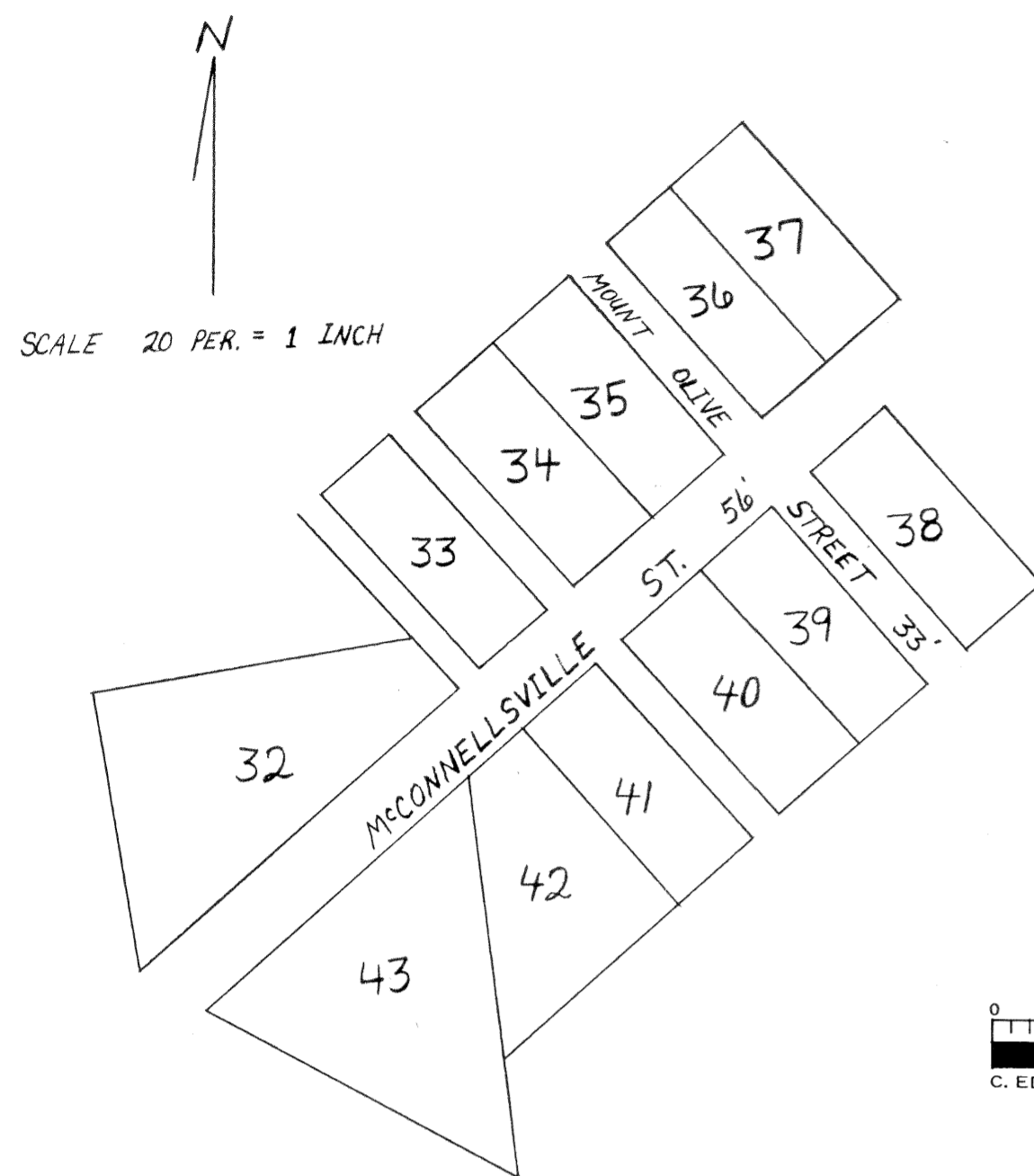


SECOND ADDITION TO MT. EPHRAIM



2nd ADDITION TO MT. EPHRAIM

THERE IS 3 ACRES & 28 RODS OF LAND LAID OUT IN LOTS, 1 ACRE 59 RODS IN STREETS & ALLEYS. IN THIS ADDITION, IN ALL 4 ACRES & 7 RODS.

PLAT OF THE 2nd ADDITION TO MT. EPHRAIM, COMMENCING AT THE S.E. COR OF LOT NO. 32, AT A STONE NUMBERED 32, RUNNING N 63 3/4° W. 10 RODS, THENCE N 86° E. 15 RODS & 7 LINKS, THENCE N 42 1/2° E. 3 RODS & 17 LINKS, THENCE S. 47 1/2° W. 18 RODS TO THE BEGINNING, CONTAINING 136 RODS. LOTS NO. 33, 34, 35, 36, 37, 38, 39, 40, 41, FRONT ON McCONNELLSVILLE ST. 4 RODS & RUN BACK 10 RODS EACH. CONTAIN 1/4 ACRE. LOT NO. 42 FRONTS ON THE ABOVE ST. 2 RODS & 23 LINKS & RUNS BACK 10 RODS ON THE BACK OF SAID LOT. 9 RODS & 5 LINKS & CONTAIN 60 RODS. LOT NO. 43 FRONTS ON THE SAME ST. 15 RODS & RUNS FROM THE S.W. COR OF LOT NO. 42, S. 9° E. 17 RODS & 3 LINKS THENCE N 63 3/4° W. 15 RODS & 6 LINKS TO SAID ST. CONTAINING 112 RODS. McCONNELLSVILLE ST. RUNS N 47 1/2° E. BY S. 47 1/2° W. & IS 56 FT. WIDE ALL THE REST OF THE ST'S & ALLEYS CROSS AT RIGHT ANGLES. MT. OLIVE ST. IS 33 FT. WIDE ALLEYS 16 1/2 FT. WIDE. I, CERTIFY THAT THE ABOVE PLAT & DESCRIPTION IS A TRUE COPY OF SURVEY MADE BY ME.

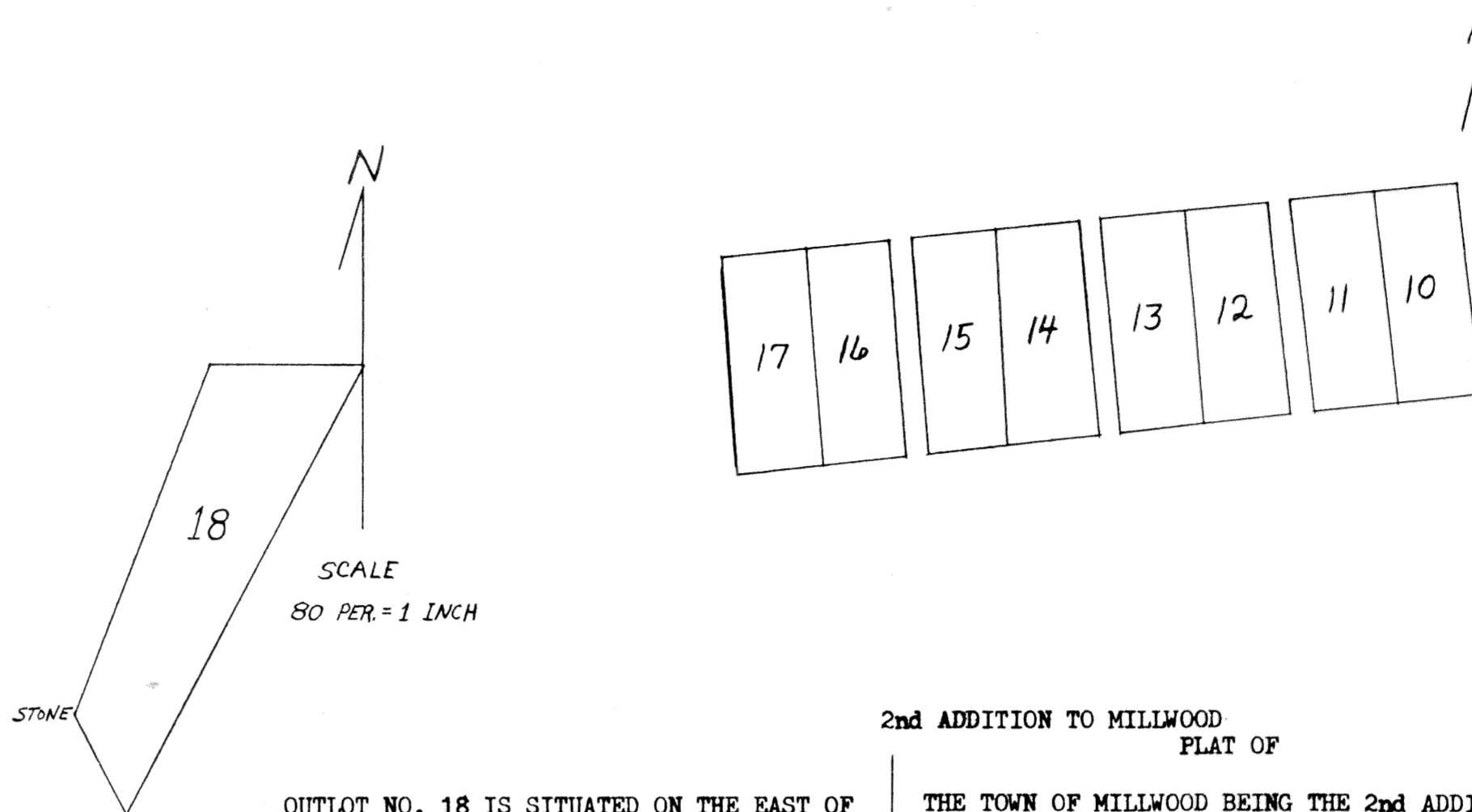

OUTLOT NO. 18 IS SITUATED ON THE EAST OF INLOT NO. 28 COMMENCED AT A STONE AT THE S.W. COR. & RUNS S. 23° 40' E. 11 3/4 PER. TO A STAKE THENCE N 26° E. 57 3/4 PER. TO A STAKE THENCE W. 18 PER. TO A STAKE. THENCE S 18 1/2° W. 45 PER & 10 LINKS TO THE BEGINNING CONTAINING 5 3/4 A. & 23 PER.

2nd ADDITION TO MILLWOOD PLAT OF

THE TOWN OF MILLWOOD BEING THE 2nd ADDITION OF OUTLOTS COMMENCING AT A STONE AT THE N.E. COR. OF LOT NO. 10 BEING WEST 1 PER. FROM THE N.W. COR. OF OUTLOT NO. 9 IN THE FIRST ADDITION TO SAID TOWN. THE LINE OF THE NORTH OF SAID LOT BEARS S 81° 50' W. & SAID LOT CUTS IN AT RIGHT ANGLES BEING S 8° 10' E. ALL OF SAID LOTS ARE ON THE EAST & WEST LINES ARE 4 PER. & ON THEIR NORTH & SO. LINES ARE 10 PER. & EACH LOT CONTAINS 1/4 ACRE ALLEYS EACH ARE 16 1/2 FT. WIDE & CONTAIN 30 PER. IN ALL. LOTS & ALLEYS CONTAIN 2 ACRES & 30 PERCH. SAID ALLEYS ARE ALLOWED AS PUBLIC GROUND BY THE PROPRIETOR.
