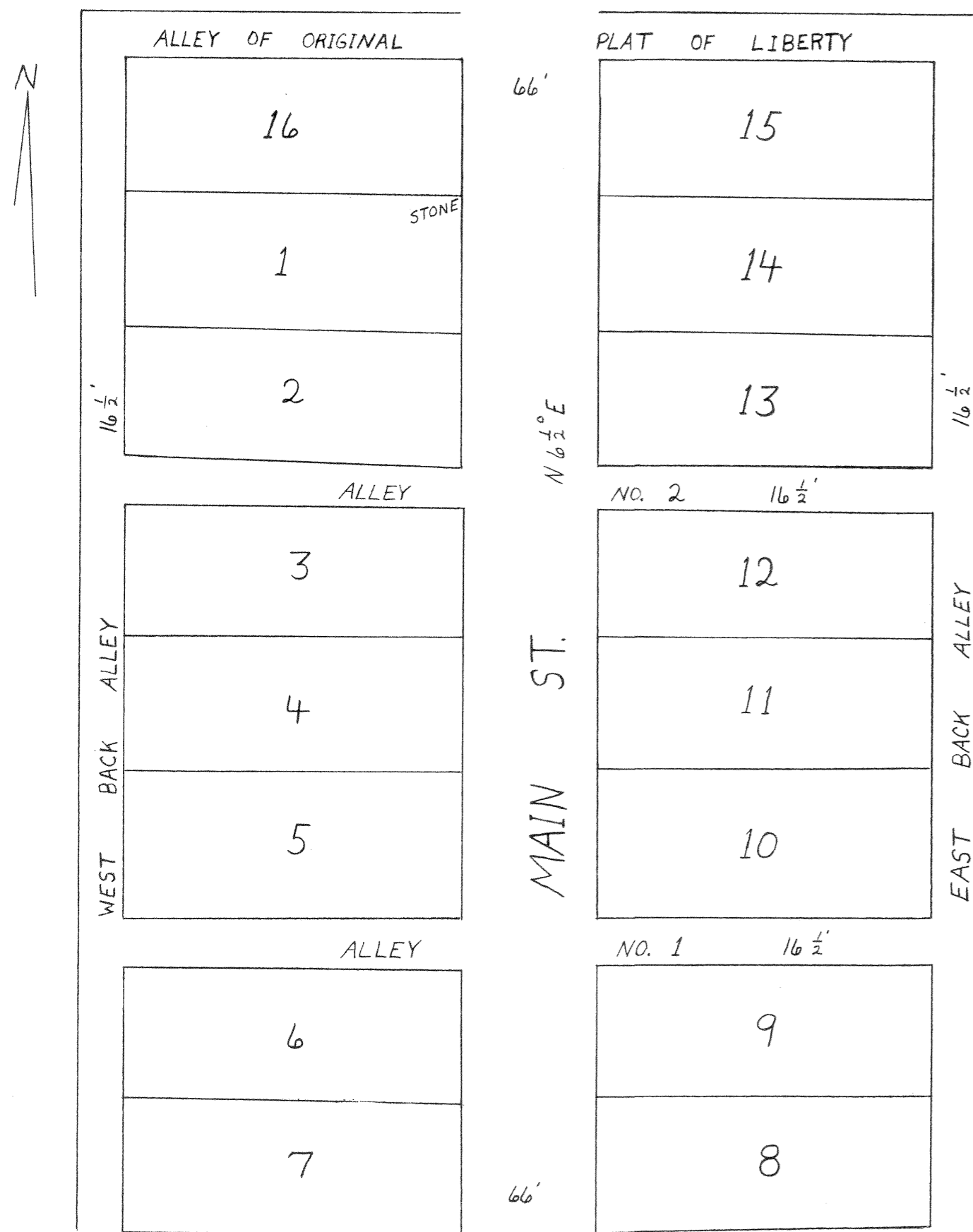

ADDITION TO LIBERTY

PLAT & DESCRIPTION OF THE FIRST ADDITION TO LIBERTY LAID OUT ON THE S.E. QUARTER OF SEC. 23 TWP. 4 R.3 THE LOTS ALL FRONT ON MAIN ST. 66 FT. AND RUN BACK AT RIGHT ANGLES 165 FT. & EACH LOT CONTAINS 40 PER. ON 1/4 ACRE. LOTS CONTAIN 4 ACRES. MAIN ST. IS 66 FT. WIDE & 35 PER. LONG BEARS N. 6 1/2° E. CONTAINING 140 PER. ALLEYS NO. 1 & 2 IS 16 1/2 FT. WIDE & 330 FT. LONG & CONTAIN 40 PER. THERE IS A BORDER ON THE EAST & WEST SIDE OF THIS ADDITION 16 1/2 FT. WIDE & CONTAINS 70 PER. & RUN PARALLEL WITH MAIN ST. 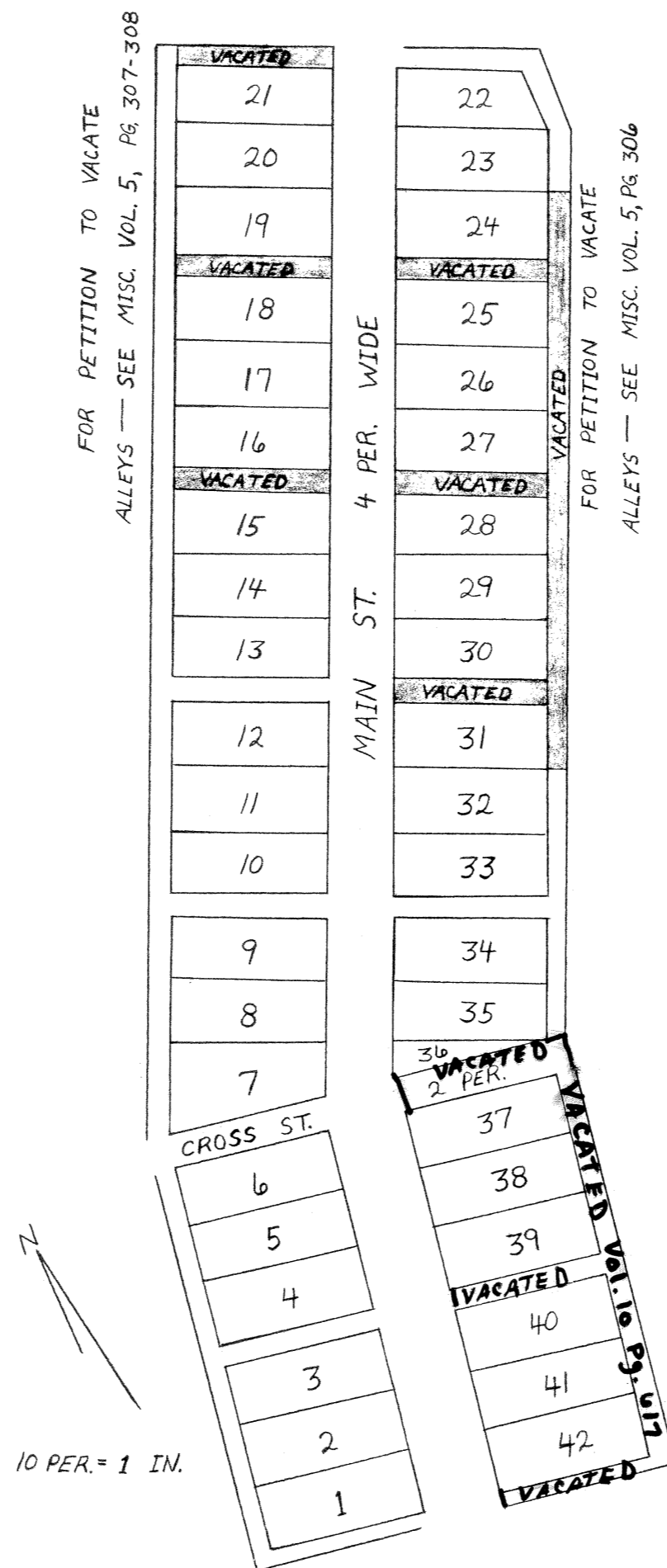

PLAT OF THE TOWN OF NEW SALEM LAID OUT BY WM. HOSSACK OF LIBERTY TWP. GUE. CO. OHIO ON THE GRADE ROAD LEADING FROM CAMBRIDGE TO THE OHIO CANAL BY WAY OF HENRY McCARLNEYS. MAIN ST. 66 FT. WIDE , CROSS ST. 33 FT. ALLEYS BETWEEN EVERY 3rd LOT ALSO BACK ALLEY 16 1/2 FT.

SAID TOWN OF NEW SALEM BEING LAID OFF IN THE WEST HALF OF N.W. QUARTER OF SEC. 1 TWP. 3 & R.3 MILITARY DISTRICT. BEGINNING FOR SAID TOWN AT A STONE IN THE S.E. COR. OF LOT NO.1. LOTS NO. 1, 2, 3, 4, 5, 6, 37, 38, 39, 40, 41, 42 BEARING IN FRONT N. 19° E. RIGTH ANGLES WITH N. 71° W. EACH OF THE ABOVE LOTS 4 PER. IN FRONT BY 10 BACK CONTAINING 40 SQ. PER. LOTS NO. 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35 BEARING IN FRONT N. 33° E. AT RIGHT ANGLES WITH N. 57° W. EACH OF THE ABOVE LOTS 4 PER. IN FRONT BY 10 PER. BACK CONTAINING 40 SQ. PER. LARGE LOT NO. 7 BEARING IN FRONT N. 33° E. 4 PER. N. SIDE OF SAID LOT AT RIGHT ANGLES WITH THE FRONT N. 57° W. 10 PER. BACK END BEARING S. 31° E. 6.4 PER. SOUTH SIDE OF SAID LOT BEARING WITH CROSS ST. S. 71° E. 10 PER. CONTAINING 51.2 SQ. PER. LOT NO. 22 BEARING IN FRONT N. 33 E. 4 PER.
