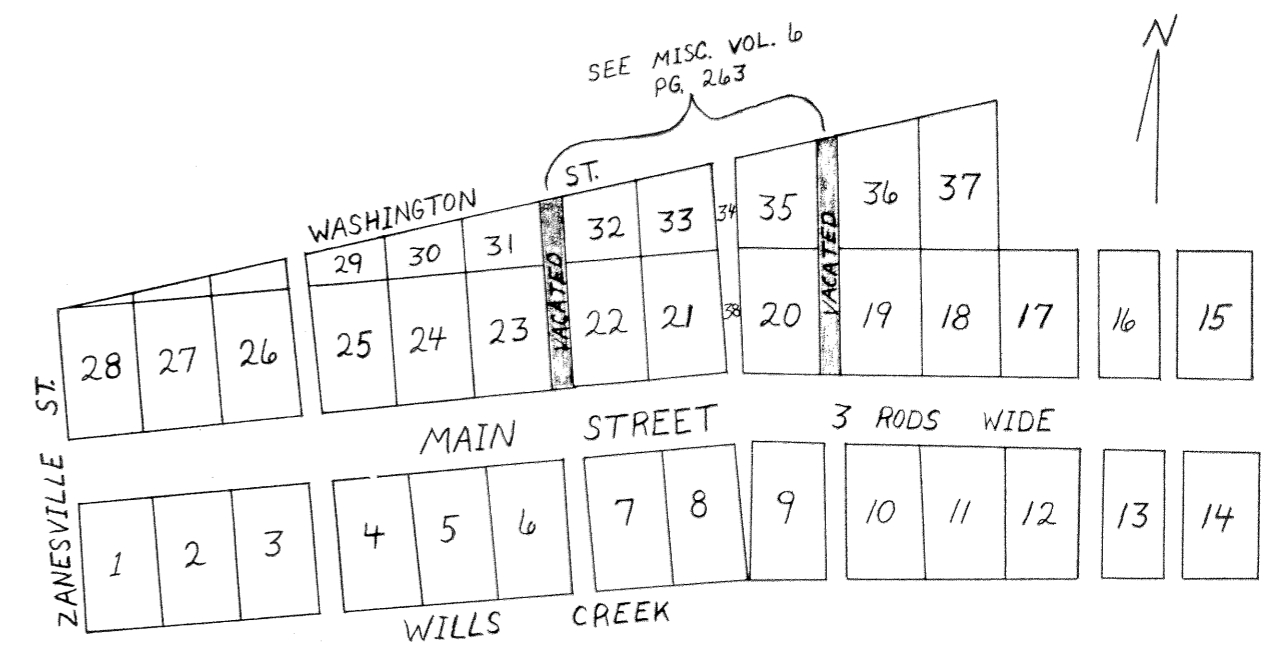

PLAT & DESCRIPTION OF THE TOWN OF BRIDGEVILLE LAID AT THE JUNCTION OF THE CAMBRIDGE COSHOCTON, ZANESVILLE & OTSEGO ROADS AT THE POINT WHERE THEY CROSS WILLS CREEK & BIRDS RUN. THE BEARING OF SAID TOWN IS S.67° E. TO THE EAST SIDE OF LOTS NO.8, 21 & 23 THENCE S.6° E. BY N.30 E. THE ALLEYS ARE AT RIGHT ANGLES WITH MAIN ST. EACH FULL LOT IS 6 PER. BY 3 1/2 PER. CONTAINING EACH 21 PERCHES. LOTS 26,27,28 HAS THE FRACTION LINE BETWEEN & WASHINGTON ST. ATTACHED TO THEM THE BALANCE OF THE FRACTIONAL LOTS LYING ON WASHINGTON ST. BEGINNING WITH LOTS NO.29 CONTAINS THE SEVERAL AMOUNTS FOLLOWING LOT NO.29 CONTAINS 6 1/4 PER. NO. 30 8 3/4 PER. NO. 31 9.80 PER. N. 32 11 1/2 PER. NO. 33-7 3/4 PER. NO. 35-16 1/2 PER.
