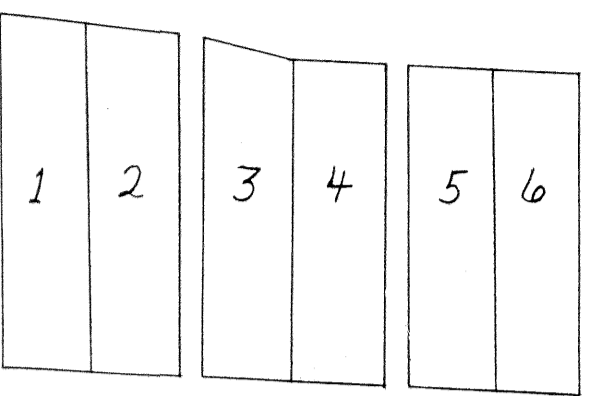


PLAT OF GREENWOOD



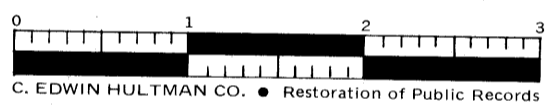
PLAT OF THE TOWN OF GREENWOOD

IN FRONT EXCEPT LOT NO. 2 WHICH IS 4.68 IN SIDE OF LOT NO. 1 RUNS N.16 PER THE LINE BETWEEN 1 & 2 IS NORTH 16 PER TO THE & 3 NORTH 15.48 PER. BETWEEN 5 & 6 N.14.60 PER. 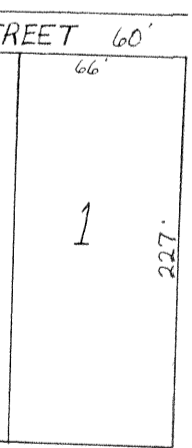

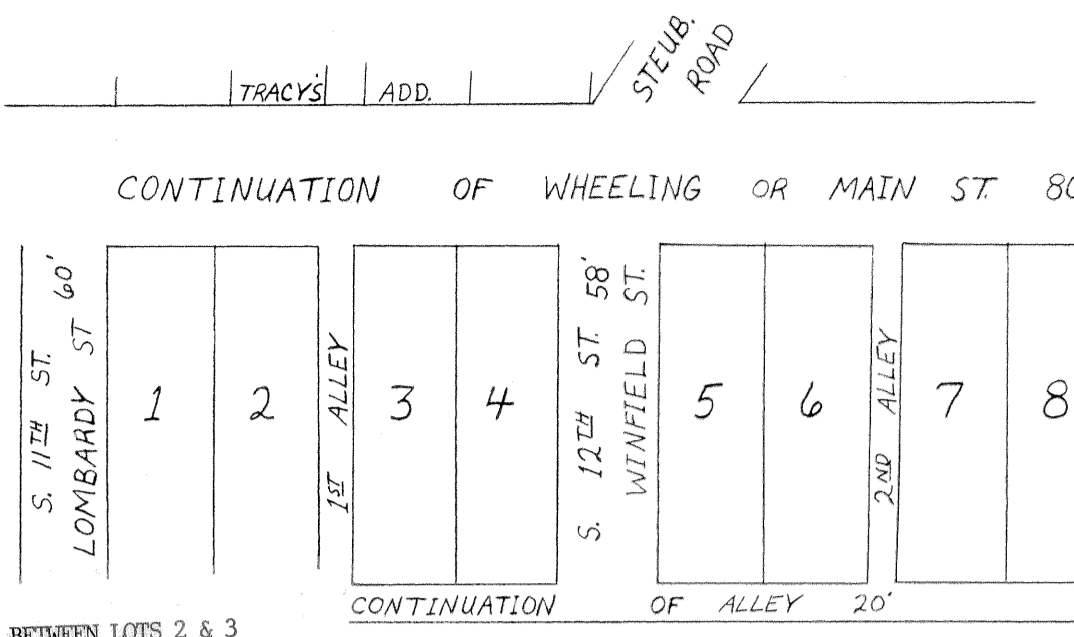

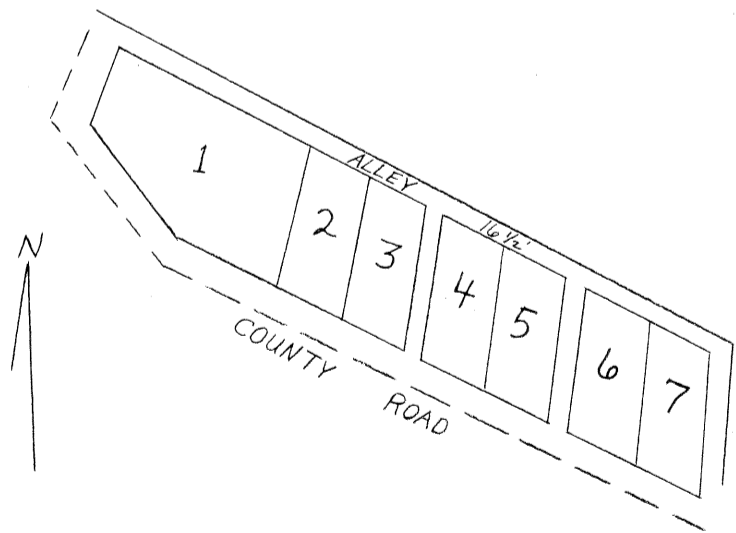
