THE COURCE & BROADTH OF MAIN ST. IN THE TOWN OF WASHINGTON IN THE STATE OF OHIO IN MUSKINGUM CO. IS S.80°E. & 66 FT. WIDE AND ALL THE STREETS & ALLEYS ARE PARALLEL OR AT RIGHT ANGLES WITH MAIN ST. AND IS OF THE FOLLOWING BROADTH. MAIN CROSS ST. 66 FT. NORTH ST. 66 FT. WIDE, ST. GEORGES ST. 33 FT. WIDE, ST. HENRYS ST. 33 FT. WIDE, EACT ST. 33 FT. WIDE, AND ALL THE ALLEYS IS $16\frac{1}{2}$ FT. WIDE. LOTS NO. 1 & 2 TO BE FOR COURT HOUSE & JAIL. LOT NO. 48 TO BE FOR A CHUCH & SCHOOL HOUSE. THE SPRING IN LOT NO. 62 TO BE FOR THE PUBLIC BENEFIT FOR THE INHABITANTS OF SAID TOWN & THE FREE RECOURSE TO BE HAD THEIR TO. THE DIMENSIONS OF EACH & EVERY LOT IS 66 FT. FRONT & REAR & 165 FT.
