

SURVEYED MAY 21st, 1856 FOR WM. BONNELL THE ABOVE ADDITION TO THE TOWN OF CAMBRIDGE. COMMENCING AT THE S.W. COR. OF WALNUT ST. WHERE IF ENTERS MAIN ST. THENCE MAIN ST. BEARS N.83½ W. BACK ALLEY BEARS N.86½ W. STEUBENVILLE ST. BEARS N.88 3/4 W. ALL THE LOTS FRONTING ON MAIN OR WHEELING ST. & STEUBENVILLE ARE 62 2/3 FT. EXCEPT LOTS NO. 1,2,27,28, EXTEND BACK 200 FT. LOTS NO. 2 & 27 ARE 59 1/3 FT. LOTS NO. 1,28 ARE 66 FT. LOTS 14 & 15 EXTEND BACK 151 1/4 THE CORNER ON LOTS ON BACK ALLEY ARE BOUND BY INTERSECTIONS OF THE STRAIGHT LINE DRAWN FROM THE CORNERS A & B & P & H.
