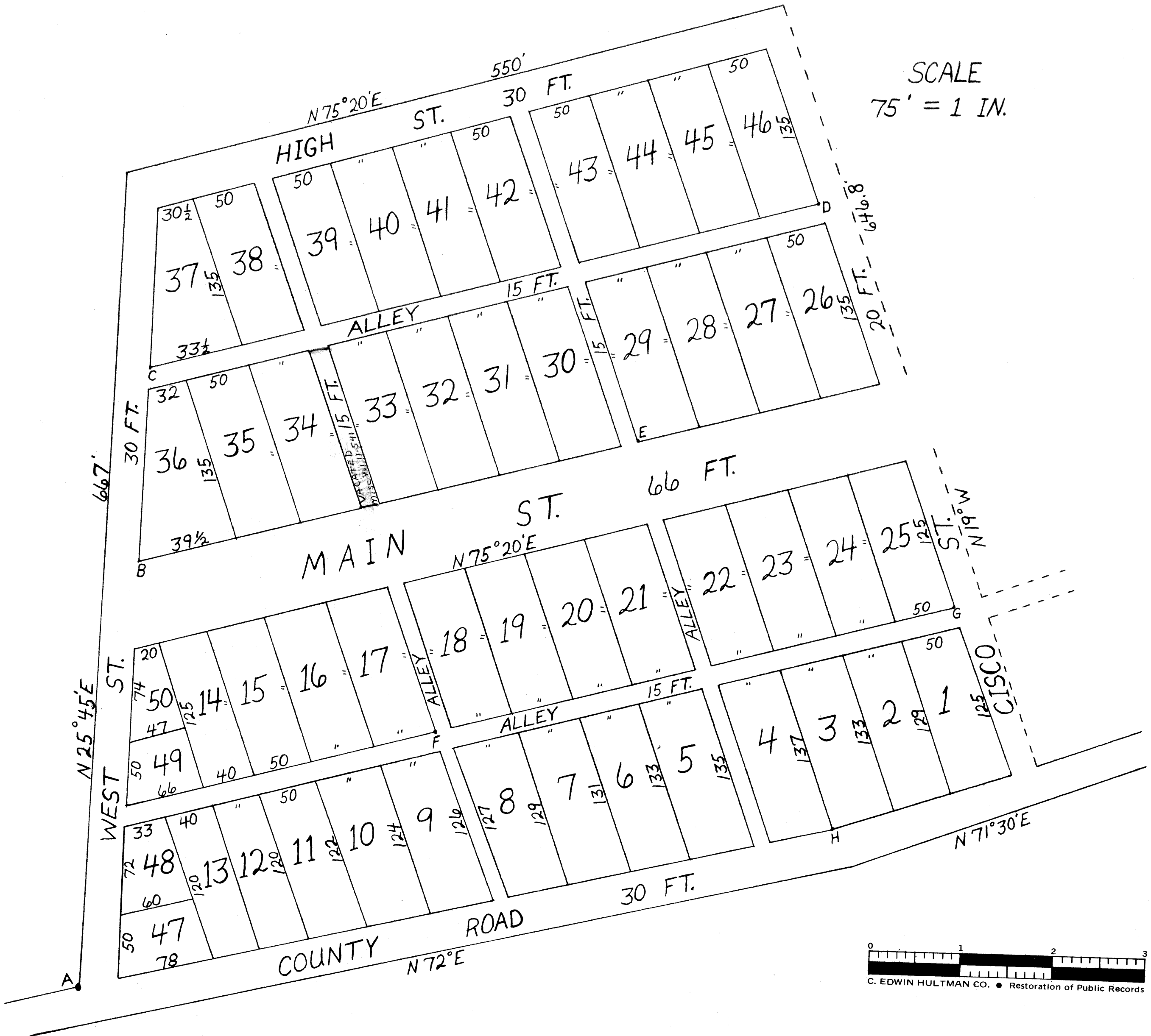

EXPLANATION OF PLAT

THE LOTS HEREON SET FORTH ARE IN THE EAST HALF OF THE NORTHWEST QUARTER OF THE SOUTH WEST QUARTER OF SECTION 8 IN TOWNSHIP 8 AND RANGE 9 VALLEY TOWNSHIP, GUERNSEY COUNTY OHIO AND COMPRISE 9 97/100 ACRE CONVEYED BY JACOB F. SECREST TO GEORGE J. MARKLEY, A FULL DESCRIPTION OF EACH LOT IS GIVEN ON THE PLAT, THE PLAT SHOW ALL STREETS & ALLEYS AND THE COURSE OF EACH LINE. STONES FROM WHICH TO MAKE FUTURE SURVEYS WERE LOCATED AT A-B-C-D-E-F-G-H. ALL MEASUREMENTS IN FEET. I HEREBY THAT THE FOREGOING PLAT AND EXPLANATORY NOTES ARE CORRECT.
