

AND RANGE NINE (9) AND BOUNDED AS FOLLOWS VIZ: BEGINNING AT A POINT SOUTH SIXTEEN DEGREES

AND TEN MINUTES EAST SIXTEEN FEET FROM THE SOUTH EAST CORNER OF LOT NO. FIVE (5) JACKSONS

ADDITION TO THE TOWN OF POINT PLEASANT (NOW PLEASANT CITY), THENCE SOUTH EIGHTY—ONE

DEGREES AND FIFTEEN MINUTES WEST ONE HUNDRED AND FORTY EIGHT AND ONE HALF (148½) FEET:
