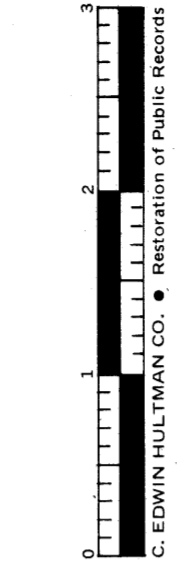
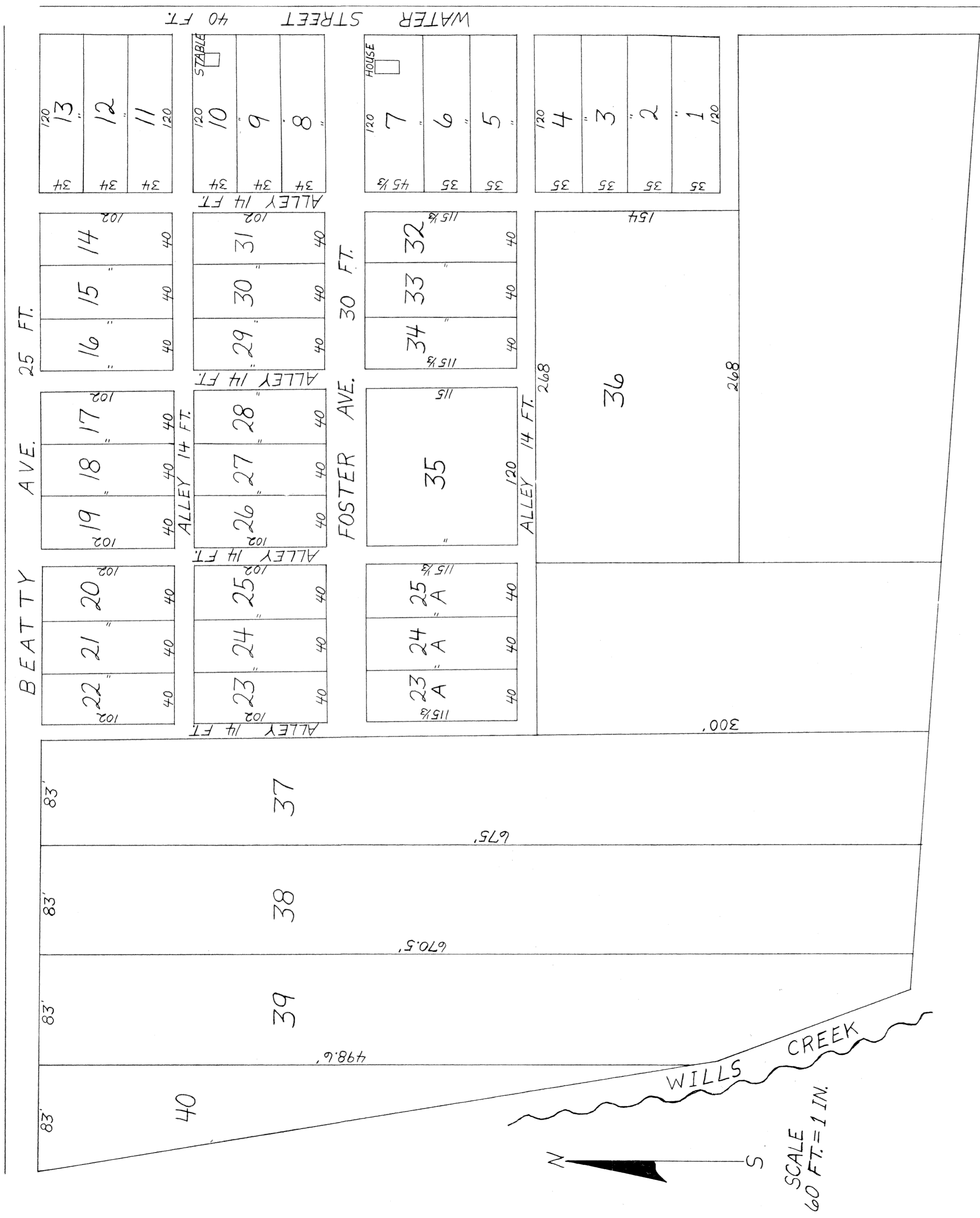


THOMAS'S ADDITION TO CAMBRIDGE, OHIO, GUE. CO.

THE SAID ADDITION BEING A PART OF THE TRACT OF LAND DESCRIBED AS FOLLOWS: SITUATE IN CAMBRIDGE TP. GUERNSEY COUNTY, OHIO IN THE THIRD QUARTER SECOND TP. AND THIRD RANGE UNITED STATES MILITARY LANDS AND MORE PARTICULARLY DESCRIBED AND DESIGNATED ON A PLAT OF THE PARTITION OF THE LANDS OF GORDON AND SARAH P. LOFLAND MADE BY AND OF RECORD IN THE COURT OF COMMON PLEAS OF SAID COUNTY IN BOOK NUMBERTHREE (8) PAGE 544 AS LOTS NINETEEN & TWENTY AND CONTAINING FOURTEEN AND 19/100 ACRES MORE OR LESS, BEING THE SAME PREMISES WHICH JOHN THOMAS AND MARY M.
