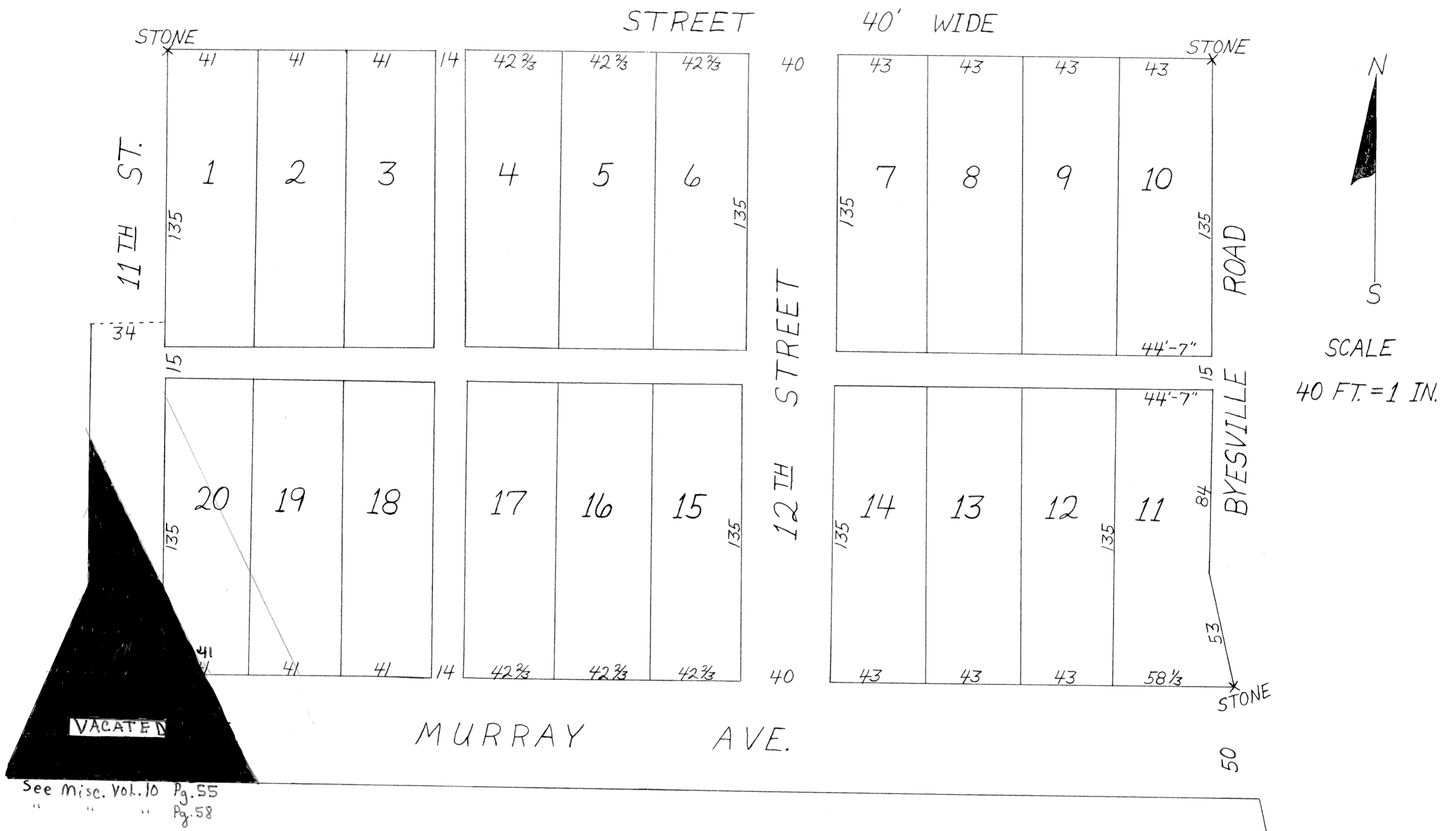


MORTON'S ADDITION TO CAMBRIDGE, OHIO

CAMBRIDGE, FEBRUARY, 1894

AT THE REQUEST OF THE EXECUTORS OF ISAAC MORTON'S WILL, I MADE A SURVEY OF A PIECE OF LAND LYING EAST OF THE CEMETERY IN THE VILLAGE OF CAMBRIDGE WHICH PIECE OF LAND IS DESCRIBED BY BEGINNING AT A POINT ON THE WEST SIDE OF THE BYESVILLE ROAD AND FORTY FEET SOUTH FROM THE NORTH SIDE OF A STREET ADJOINING SAID PIECE OF LAND ON THE NORTH AND THENCE WESTERLY 477 FEET AND EVERYWHERE FORTY FEET SOUTH OF THE NORTH SIDE OF SAID STREET; THENCE SOUTHERLY 126 FEET ALONG THE EAST SIDE OF 11th STREET, THENCE WESTERLY 34 FEET; THENCE S. 3 W. 120 FEET; THENCE S. 25 W. 96 FEET; THENCE EASTERLY PARALLEL WITH FIRST MENTIONED STREET TO THE BYESVILLE ROAD; THENCE N. 10 1/2 W. 104 FEET THENCE NORTHERLY 234 FEET ALONG SAID BYESVILLE ROAD TO THE BEGINNING. ALSO I LAID OUT SAID PIECE OF LAND INTO LOTS, STREETS AND ALLEYS AS SHOWN BY ACCOMPANYING PLAT. THE DISTANCES ARE GIVEN IN FEET AND ARE MARKED IN BLACK INK. THE LOT NUMBERS ARE MARKED IN RED INK ON THE SEVERAL LOTS.
