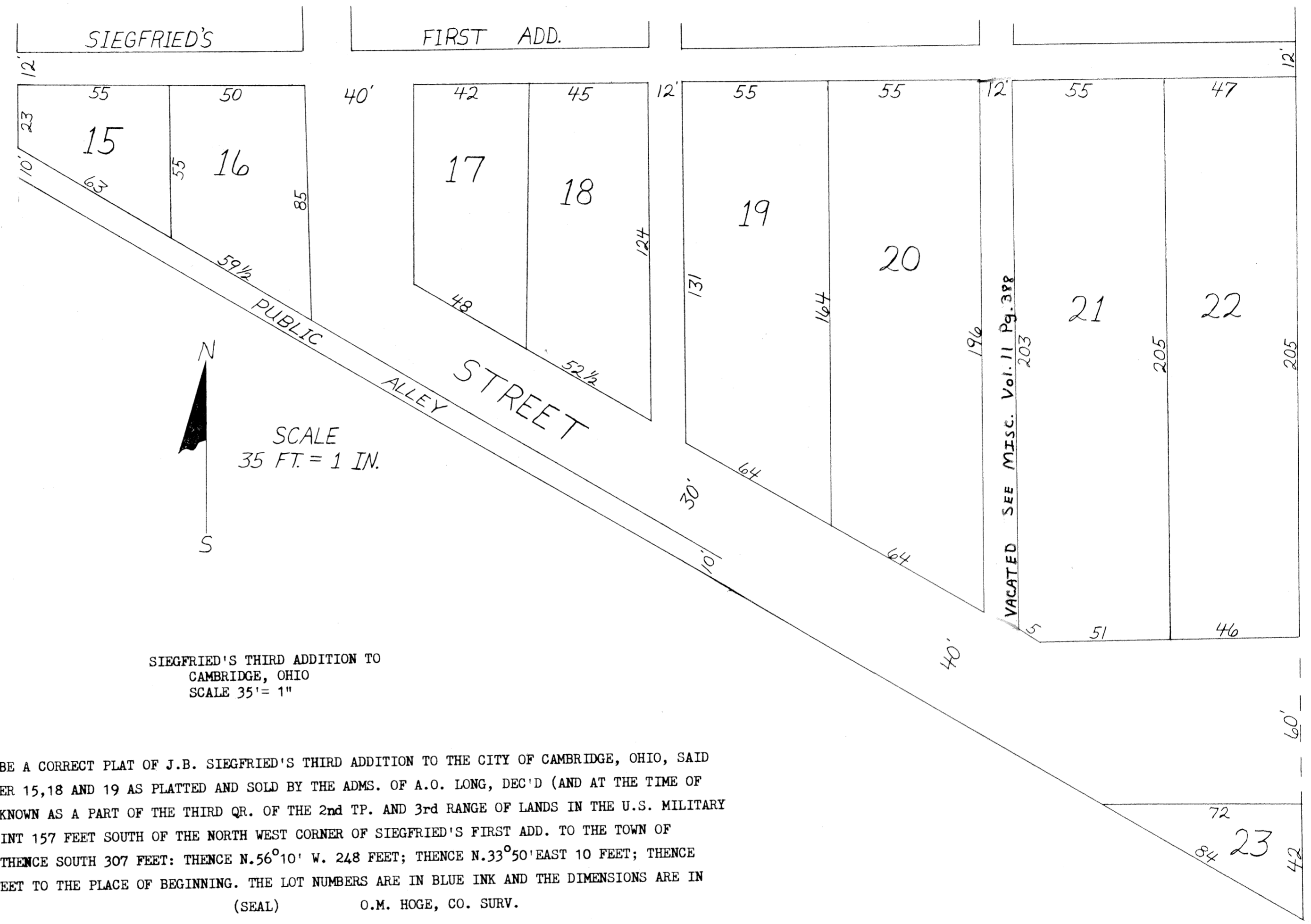

SIEGFRIED'S THIRD ADDITION TO THE CITY OF CAMBRIDGE, OHIO, SAID ADDITION BEING A PART OF OUT LOTS NUMBER 15, 18 AND 19 AS PLATTED AND SOLD BY THE ADMS. OF A.O. LONG, DEC'D (AND AT THE TIME OF THE SUB-DIVISION SAID REAL ESTATE WAS KNOWN AS A PART OF THE THIRD QR. OF THE 2nd TP. AND 3rd RANGE OF LANDS IN THE U.S. MILITARY DISTRICT) SAID ADDITION BEGINS AT A POINT 157 FEET SOUTH OF THE NORTH WEST CORNER OF SIEGFRIED'S FIRST ADD. TO THE TOWN OF CAMBRIDGE OHIO, THENCE EAST 468 FEET, THENCE SOUTH 307 FEET; THENCE N.56°10' W. 248 FEET; THENCE N.33°50' EAST 10 FEET; THENCE N.56°10' W. 297 FEET; THENCE NORTH 23 FEET TO THE PLACE OF BEGINNING. THE LOT NUMBERS ARE IN BLUE INK AND THE DIMENSIONS ARE IN RED INK AND DENOTE FEET.
