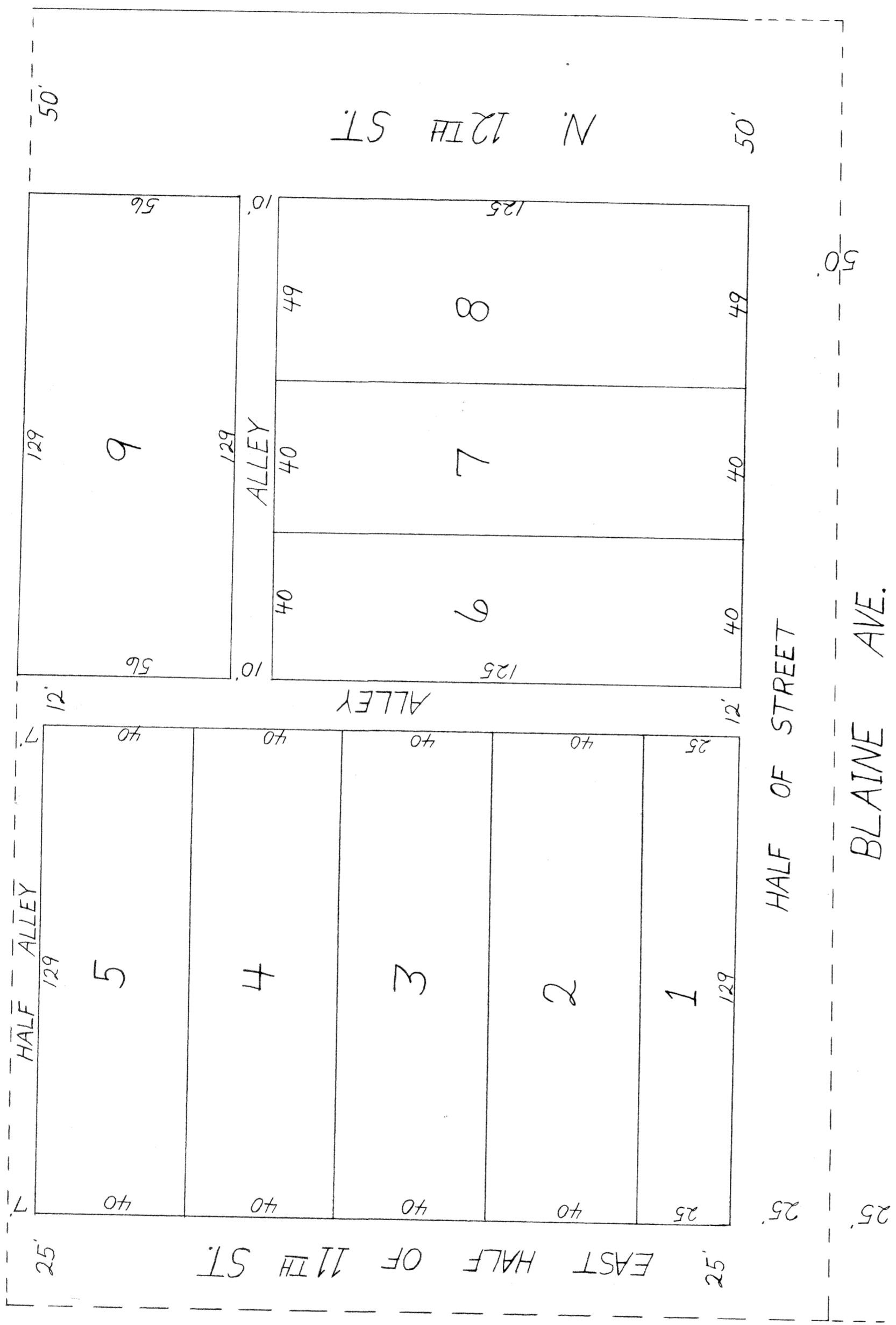


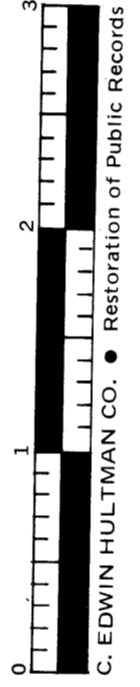
A.J. HUNT'S ADDITION TO CAMBRIDGE, OHIO
