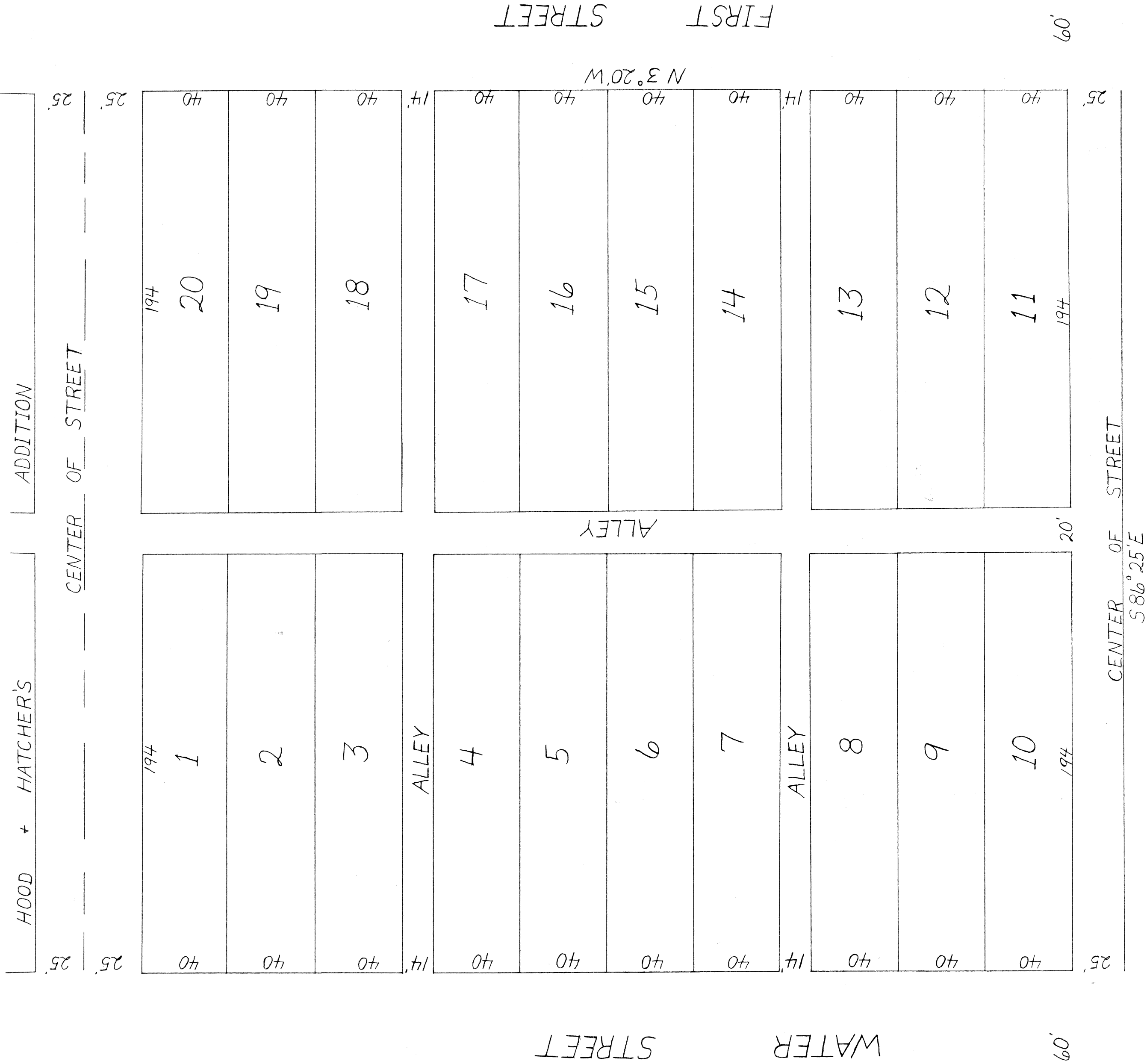


DUNHAM'S ADDITION, CAMBRIDGE, OHIO
