PLAT OF THE TOWN SITE OR VILLAGE OF RIGBY, BEING PART OF THAT PART OF THE NORTHEAST QUARTER OF SECTION FOUR (4) IN TOWNSHIP ONE(1) AND RANGE TWO (2) IN CENTRE TOWNSHIP, GUERNSEY COUNTY, OHIO, LYING SOUTH AND WEST OF THE RIGHT OF WAY OCCUPIED BY THE CENTRAL OHIO AND BALTIMORE AND OHIO RAILROAD COMPANIES AND BOUNDED ON THE EAST AND NORTHEAST BY THE COUNTY ROAD, CONSISTING OF FULLY FORTY (40) LOTS NUMBERED FROM ONE (1) TO FORTY (40) INCLUSIVE AND OF THE STREETS AND ALLEYS SHOWN SAID LOTS BEING OF THE DIMENSIONS IN FEET THEREIN RESPECTIVELY SHOWN, AND ALL THEREOF EXCEPT NO. NINE (9) AND NO. FORTY (40) HAVING SEVENTY-FIVE (75) FEET FRONTAGE, SAID ALLEYS BEING SIXTEEN (16) FEET WIDE AND SAID STREETS BEING FORTY (40) FEET WIDE AND THE COURSES OF SAID STREETS BEING NORTH FIVE (5) DEGREES EAST AND THE COURSE OF SAID ALLEYS BEING NORTH EIGHTY-FIVE (85) DEGREES WEST, ALLOWING A VARIATION OF THREE (3) DEGREES THIRTY-FIVE MINUTES WEST. THE EASTERN MOST OF SAID STREETS BEING NAMED MCKINLEY STREET, AND THE WESTERN MOST THEREOF BEING NAMED DEWEY STREET. A STONE IS PLANTED AT THE NORTHWEST CORNER OF LOT THREE (3) AND ANOTHER AT THE SOUTH WEST CORNER OF LOT TWENTY-ONE (21).
