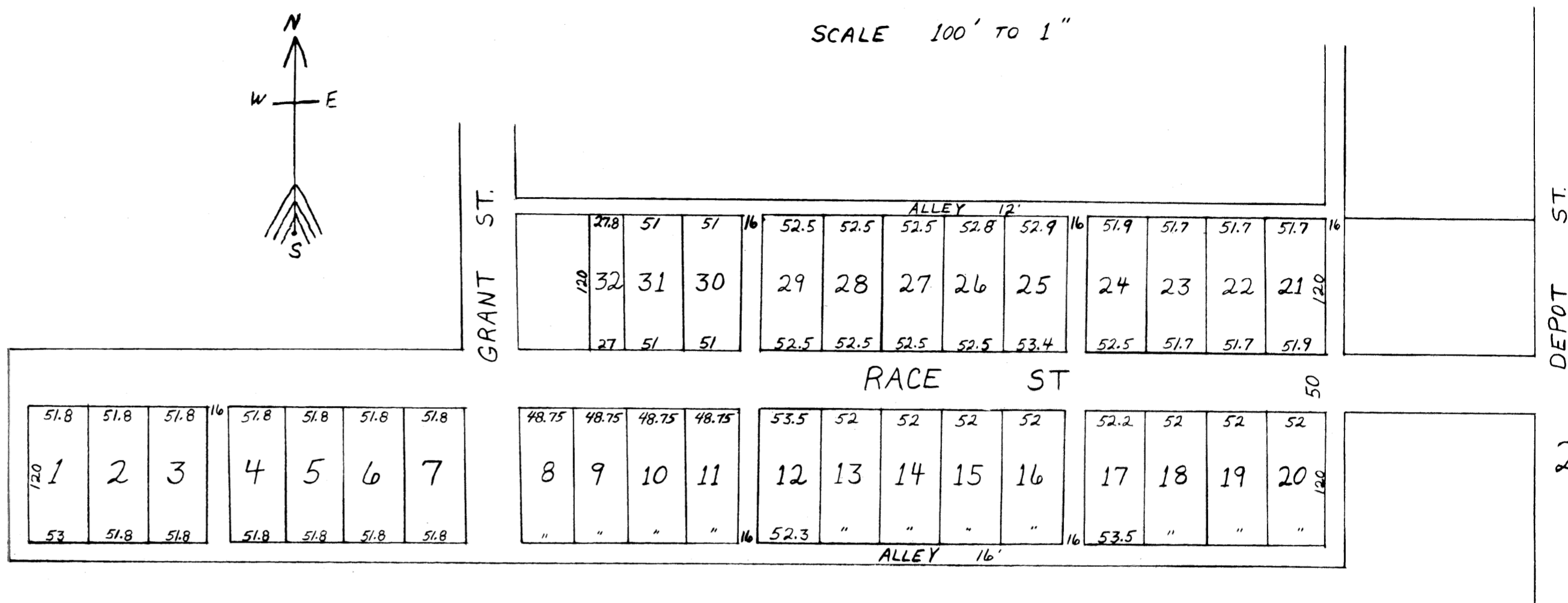
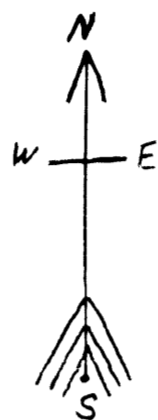


PLAT OF RINGER'S SECOND

AT THE REQUEST OF J. W. RINGER AND BY HIS DIRECTION, I MADE THE FOLLOWING SURVEY ON LOT NO. 1 IN THE S.E. QUARTER OF TWP. NO. 1, RANGE 3 OF THE ZANESVILLE LAND DISTRICT BEING NOW A PART OF JACKSON TWP. GUERNSEY CO. O. BEGINNING AT A STAKE 165 FEET WEST FROM A STONE ON WEST SIDE OF DEPOT ST. AT THE S.E. CORNER OF A LOT OF LAND OWNED BY GEORGE DUDLEY. THENCE WEST 648 FT. TO A STAKE IN THE NORTH EAST CORNER OF A LOT OWNED BY E. MACKLEY. 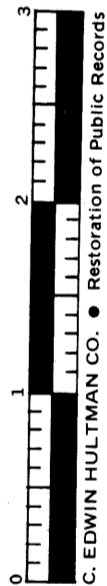
