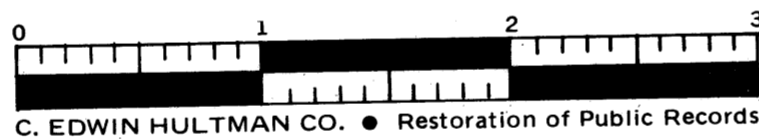
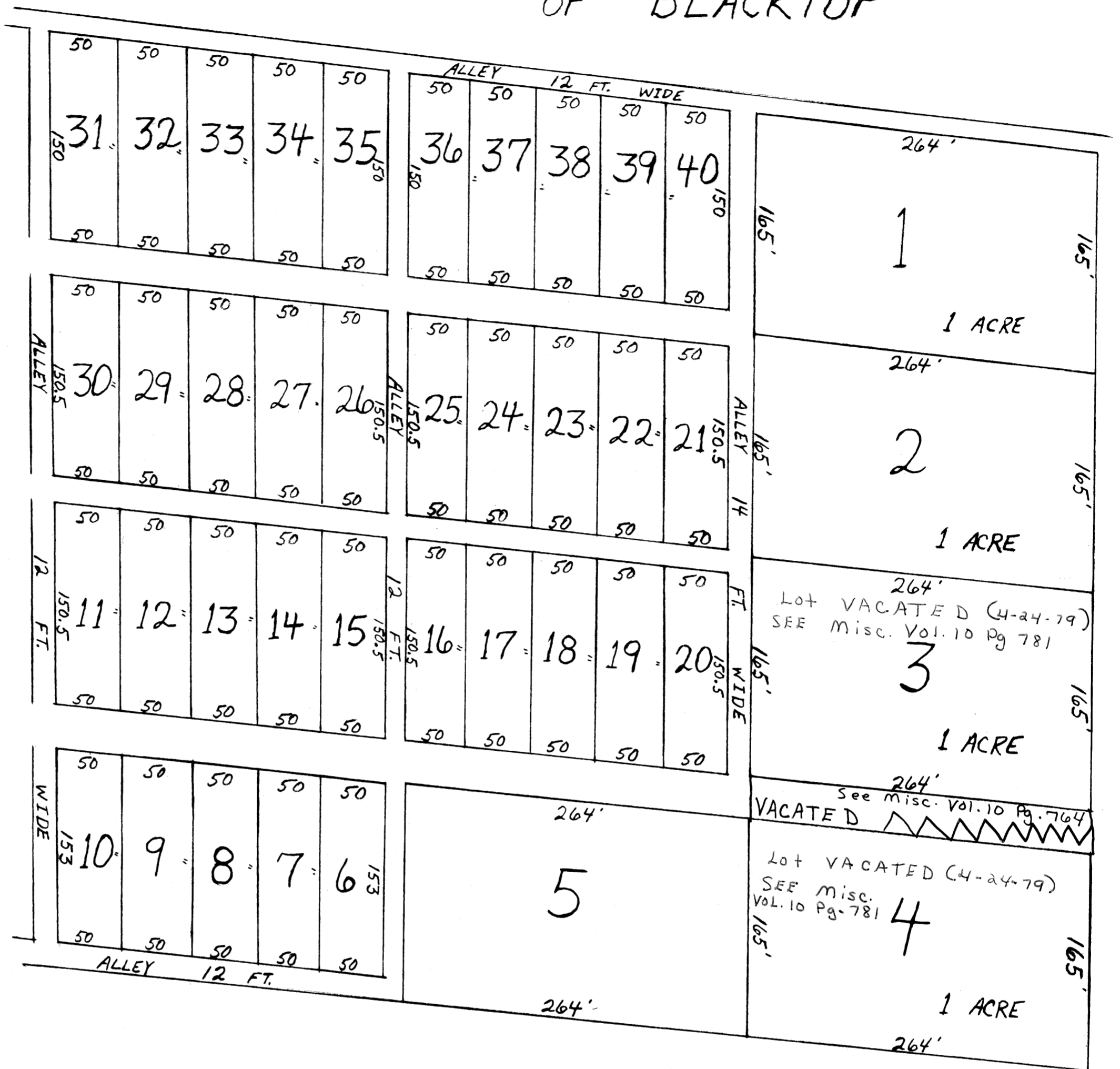
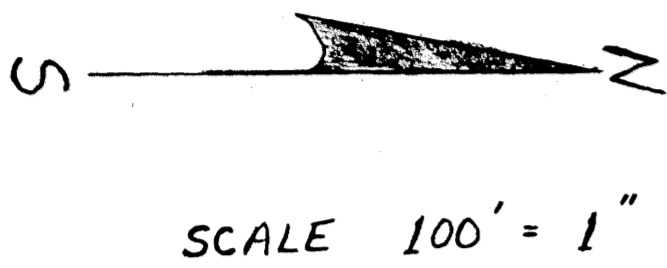


# PLAT OF THE TOWN OF BLACKTOP

DESCRIPTION: BEING A PART OF THE SOUTH PART, OF THE WEST SIDE, OF THE SOUTH EAST QUARTER OF SECTION EIGHT (8) TOWNSHIP ONE (1) OF RANGE (2) AND BOUNDED AS FOLLOWS- BEGINNING FOR THE SAME AT THE NORTH-EAST CORNER OF THE TRACT OF LAND FORMERLY CONVEYED TO M. L. SPAID, BY M. E. SMITH AND HELEN C. SMITH, HUSBAND AND WIFE, BY WARRANTY DEED DATED FEBRUARY 13TH, A.D. 1891: THENCE SOUTH 13°30' WEST EIGHT HUNDRED AND TWO (802) FEET: THENCE WEST SEVEN HUNDRED AND TWO (702) FEET: THENCE NORTH 13°30' EAST EIGHT HUNDRED AND TWO (802) FEET: THENCE EAST SEVEN HUNDRED AND TWO (702) TO THE PLACE OF BEGINNING, AND CONTAINING TWELVE AND EIGHTY FOUR HUNDREDTH (12.84) ACRES MORE OR LESS.
