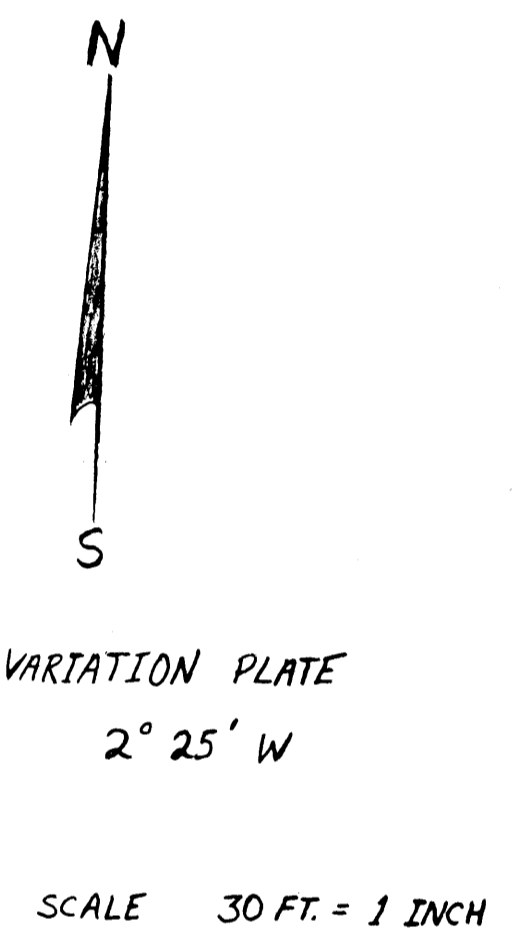
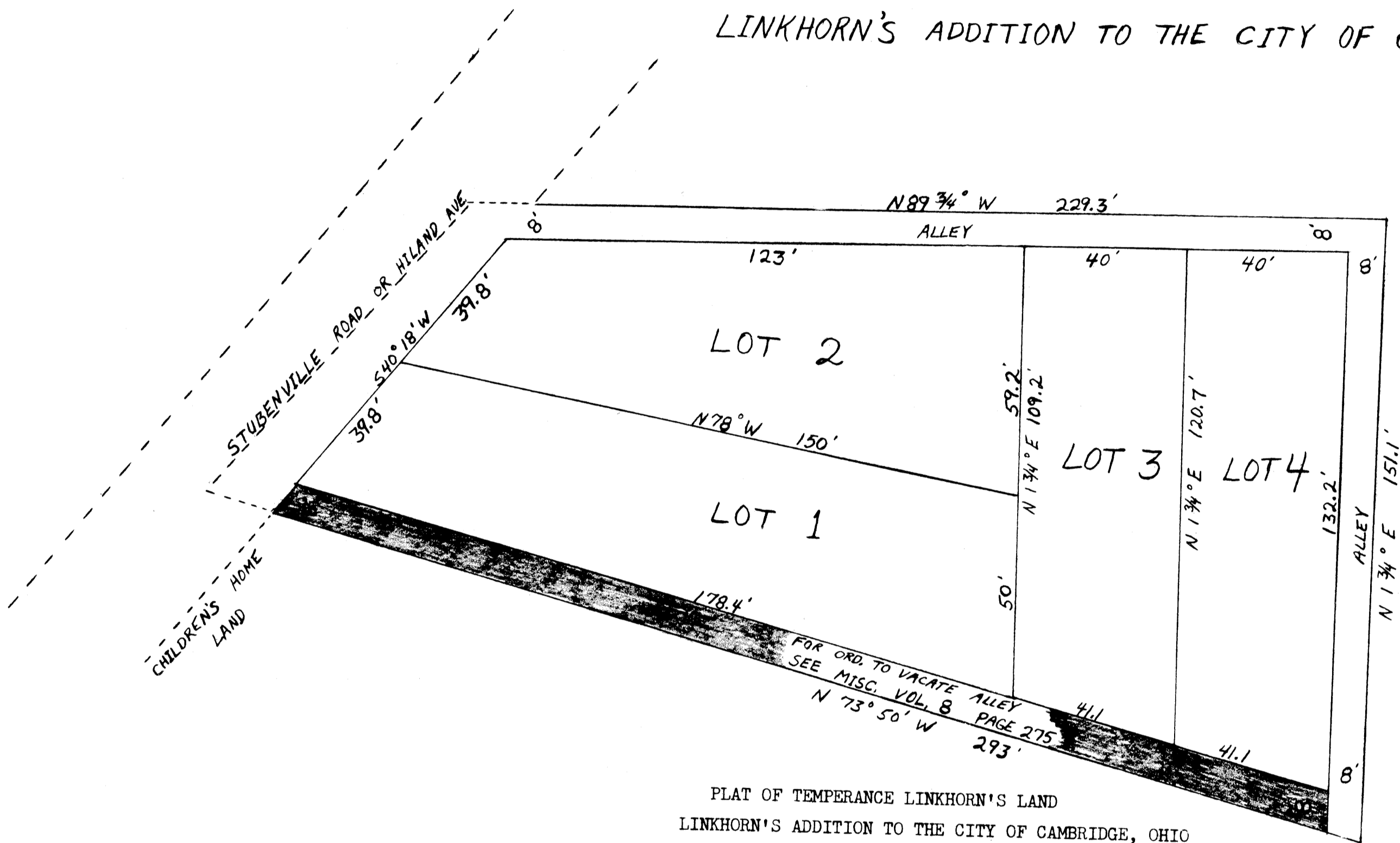


PLAT OF TEMPERANCE LINKHORN'S LAND

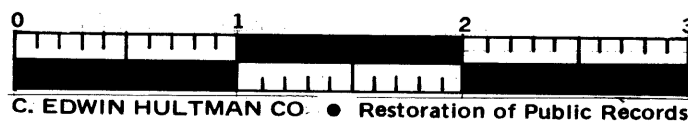
