AT THE REQUEST AND BY THE DIRECTIONS OF H.H. WILSON AND L.O. RIDDLE I MADE THE FOLLOWING SURVEY ON MILITARY LOT NUMBER ONE IN TOWNSHIP ONE OF RANGE THREE OF THE MILITARY LAND DISTRICT OF ZANESVILLE NOW A PART OF JACKSON TOWNSHIP, GUERNSEY COUNTY O. BEGINNING FOR THE SAME AT A POINT FORTY FIVE (45) FEET WEST OF A STONE IN NORTHEAST CORNER OF RINGER'S FIRST ADDITION TO THE TOWN OF BYESVILLE AND ON THE NORTH LINE OF THE SAID MILITARY LOT NUMBER ONE. RUNNING THENCE WEST ALONG SAID LINE ON THE SOUTH LINE OF THE SOUTH ALLEY OF THE SAID RINGER'S ADDITION FOUR HUNDRED AND FIFTY TWO (452) FEET TO THE SOUTHWEST CORNER OF THE SAID RINGER'S ADDITION. THENCE SOUTH ONE HUNDRED AND SIXTY FIVE (165) FEET. THENCE WEST ONE HUNDRED AND NINETY EIGHT (198) FEET. THENCE SOUTH FIVE HUNDRED AND SIXTY FIVE (565) FEET. THENCE WEST ONE HUNDRED AND SEVENTY SIX (176) FEET. THENCE SOUTH TWO HUNDRED AND NINETY SEVEN (297) FEET. THENCE EAST FOUR HUNDRED AND TWO (402) FEET. THENCE NORTH SIX HUNDRED AND FIFTY SIX (656) FEET. THENCE EAST (407.58) FEET. THENCE NORTH (376.52) FEET TO THE BEGINNING, CONTAINING 9.35 ACRES MORE OR LESS.

I LAID OUT SAID PIECE OF LAND IN LOTS, STREETS AND ALLEYS IN MANNER FORM AND SIZE AS DELINEATED ON THE ACCOMPANYING PLAT, THE DISTANCES ARE GIVEN IN FEET DECIMALS AND ARE MARKED ON OR NEAR THE LINES TO WHICH THEY REFER. THE NUMBER OF EACH LOT IS MARKED ON ITS CORRESPONDING LOT.

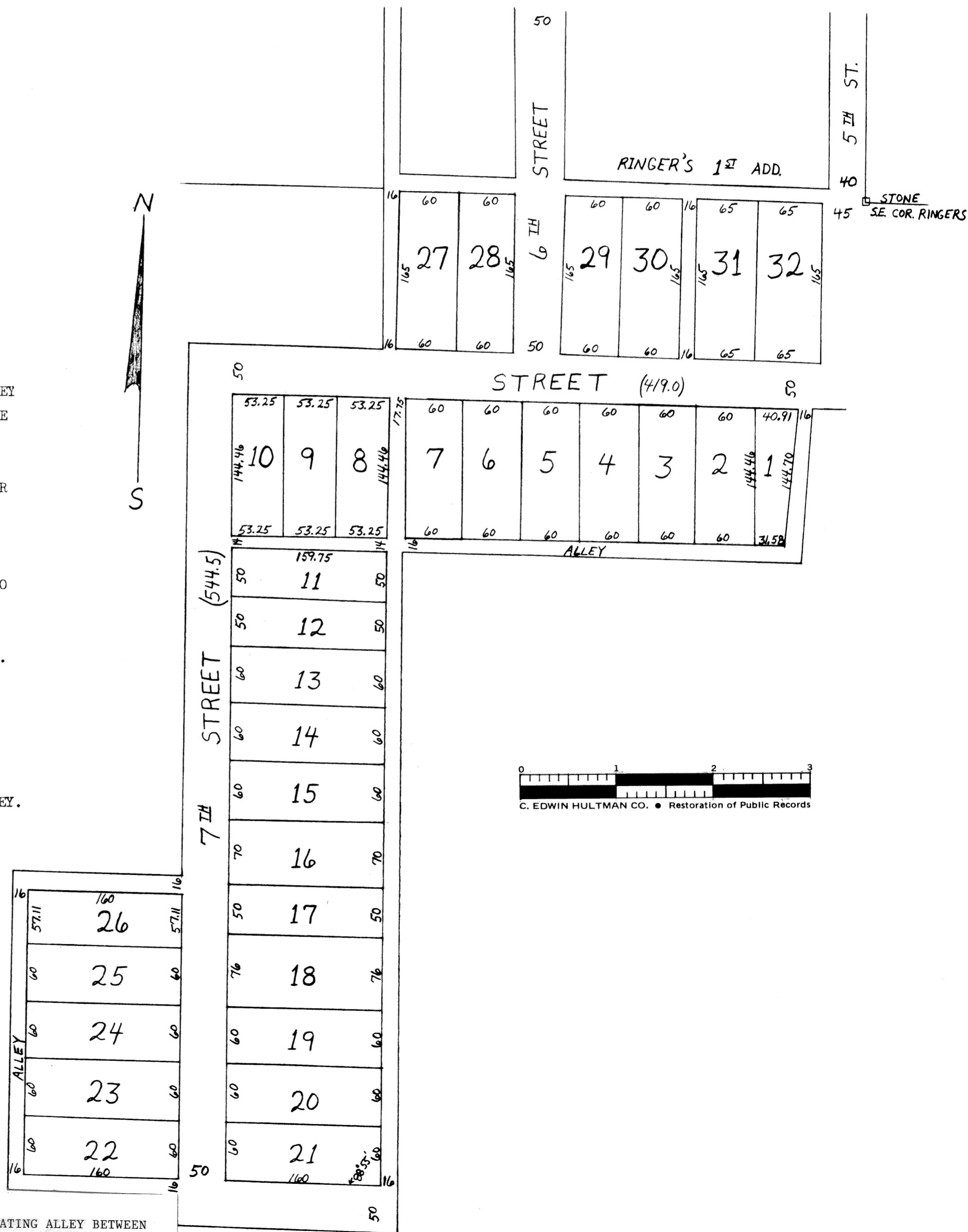
