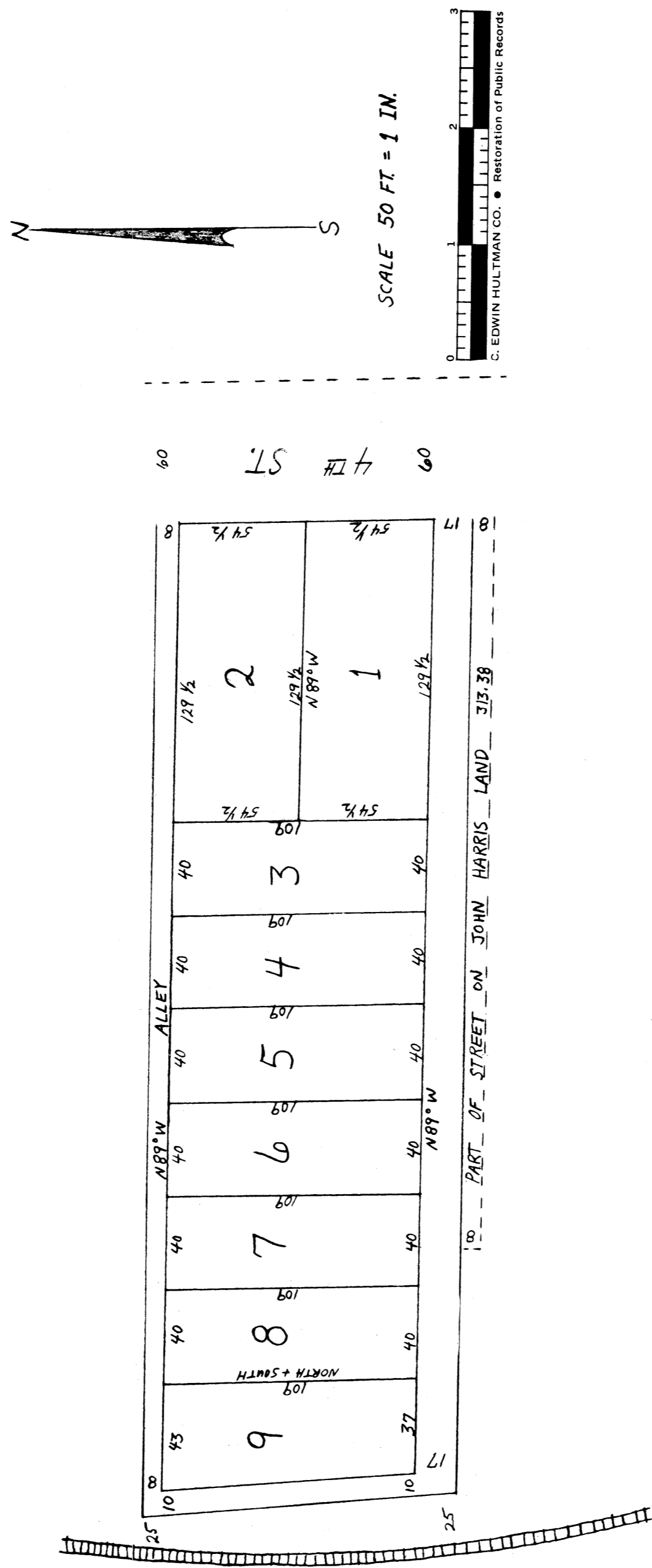


SAREPTA B. OGIERS ADDITION TO THE CITY OF CAMBRIDGE OHIO

MARQUAND THE PROPRIETORS OF THE LANDS DELINEATED ON THE ABOVE PLAT, DO HEREBY ACKNOWLEDGE THE MAKING OF THE SAME TO BE THEIR FREE ACT AND DEED, AND WE DO HEREBY DEDICATE THE STREETS AND ALLEYS AS SHOWN THEREON TO THE CITY OF CAMBRIDGE FOR PUBLIC USE FOREVER. IN TESTIMONY WHEREOF, WE HEREUNTO SET OUR HANDS THIS 27TH DAY OF SEPTEMBER 1900.
