PETITION BY THE INCORPORATED VILLAGE OF SENECVILLE, OHIO, FOR THE ANNEXATION OF TERRITORY. TO THE COMMISSIONERS OF GUERNSEY COUNTY, OHIO. GENTLEMEN: THE VILLAGE OF SENECVILLE IN SAID COUNTY RESPECTFULLY REPRESENTS THAT BY AN ORDINANCE DULY PASSED BY ITS COUNCIL ON THE 6th DAY OF FEB. 1906, THE FOLLOWING DESCRIBED TERRITORY, TO WIT: ALL THE TERRITORY NOT INCLUDED WITHIN THE PRESENT CORPORATE LIMITS OF SAID VILLAGE AND INCLUDED WITHIN THE BOUNDARIES HEREINAFTER SET OUT TO WIT. COMMISSIONERS MET IN THEIR OFFICE ON ABOVE DATE AS PER ADJOURNMENT ALL MEMBERS BEING PRESENT: VIZ BEGGS, SMITH, AND MOORE MINUTES OF PREVIOUS MEETING READ AND APPROVED. IN THE MATTER OF THE PETITION OF SENECVILLE TO EXTEND CORPORATION LINES: THIS 5th DAY OF JUNE 1906 BEFORE THE BOARD OF COUNTY COMMISSIONERS OF GUERNSEY COUNTY, OHIO, ALL BEING PRESENT, CAME ON FOR FURTHER HEARING THE THE PETITION OF PURSUANT THE ADJOURNMENT THEREOF TO THIS DAY AND TIME HERETOFORE MADE BY ORDER OF THIS BOARD, AND SAID MATTER CAME ON FOR HEARING UPON SAID PETITION, THE MAP AND PLAT ACCOMPANYING THE SAME AND THE EVIDENCE, AND WAS HEARD THEREON, AND SUBMITTED TO THE COMMISSIONERS ON CONSIDERATION WHEREOF THE COMMISSIONERS FIND THAT SAID PETITION CONTAINS ALL THE MATTERS REQUIRED THAT ITS STATEMENTS ARE TRUE, THAT NOTICE HAS BEEN GIVEN AS REQUIRED AND THAT WITH THE EXCEPTIONS HEREINAFTER SET OUT, THE LIMITS PROPOSED ARE NOT UNREASONABLY LARGE OR SMALL AND THAT SAID MAP OR PLAT IS ACCURATE, SAID EXCEPTIONS BEING AS FOLLOWS TO WIT: CERTAIN OF THE TERRITORY PROPOSED TO BE ANNEXED, LYING SOUTH AND EAST OF THE PRESENT TOWN OUGHT NOT TO BE ANNEXED TO SAID VILLAGE, AND IN ORDER TO EXCLUDE THE SAME, THE SOUTH AND EAST BOUNDARIES OF SAID TERRITORY TO BE ANNEXED SHOULD BE CHANGED BY MAKING THE SOUTH WEST CORNER OF THE PROPOSED CORPORATE LIMITS AT THE INTERSECTION OF THE WEST LINE AS SHOWN BY SAID MAP OR PLAT WITH THE SOUTH LINE OF THE RIGHT OF WAY OF THE EASTERN OHIO RAILROAD COMPANY AS NOW OCCUPIED AND FENCED AND RUNNING THENCE WITH SAID SOUTH LINE OF SAID RIGHT OF WAY EASTWARD AND NORTHWARD TO THE INTERSECTION OF SAID SOUTH LINE OF SAID RIGHT OF WAY WITH THE SOUTH LINE OF OUT LOT NUMBER ONE (1) ATTACHED TO SAID TOWN AND SHOWN ON SAID MAP OR PLAT AND RUNNING THENCE WITH SAID SOUTH LINE OF SAID OUT LOT ONE AND OF OUT LOTS NUMBERED TWO TO SEVEN INCLUSIVE TO THE INTERSECTION THEREOF WITH THE PROPOSED LAST LINE OF SAID PROPOSED LIMITS AS BY SAID MAP AND PLAT AND WITH THIS FURTHER EXCEPTION TO THE SOUTH EAST PART OF SECTION NINETEEN AND THE NORTH EAST PART OF SECTION TWENTY TWO SHOWN ON SAID PLAT, BY DELINEATING THE SAME AS DESCRIBED IN SAID PETITION AND THUS EXCLUDING FROM SAID PROPOSED LIMITS THE CEMETERY THERE SITUATE AND ALSO THE HIGHWAYS BOUNDING SAID CEMETRY ON THE EAST AND NORTH OF SAID CEMETERY.
