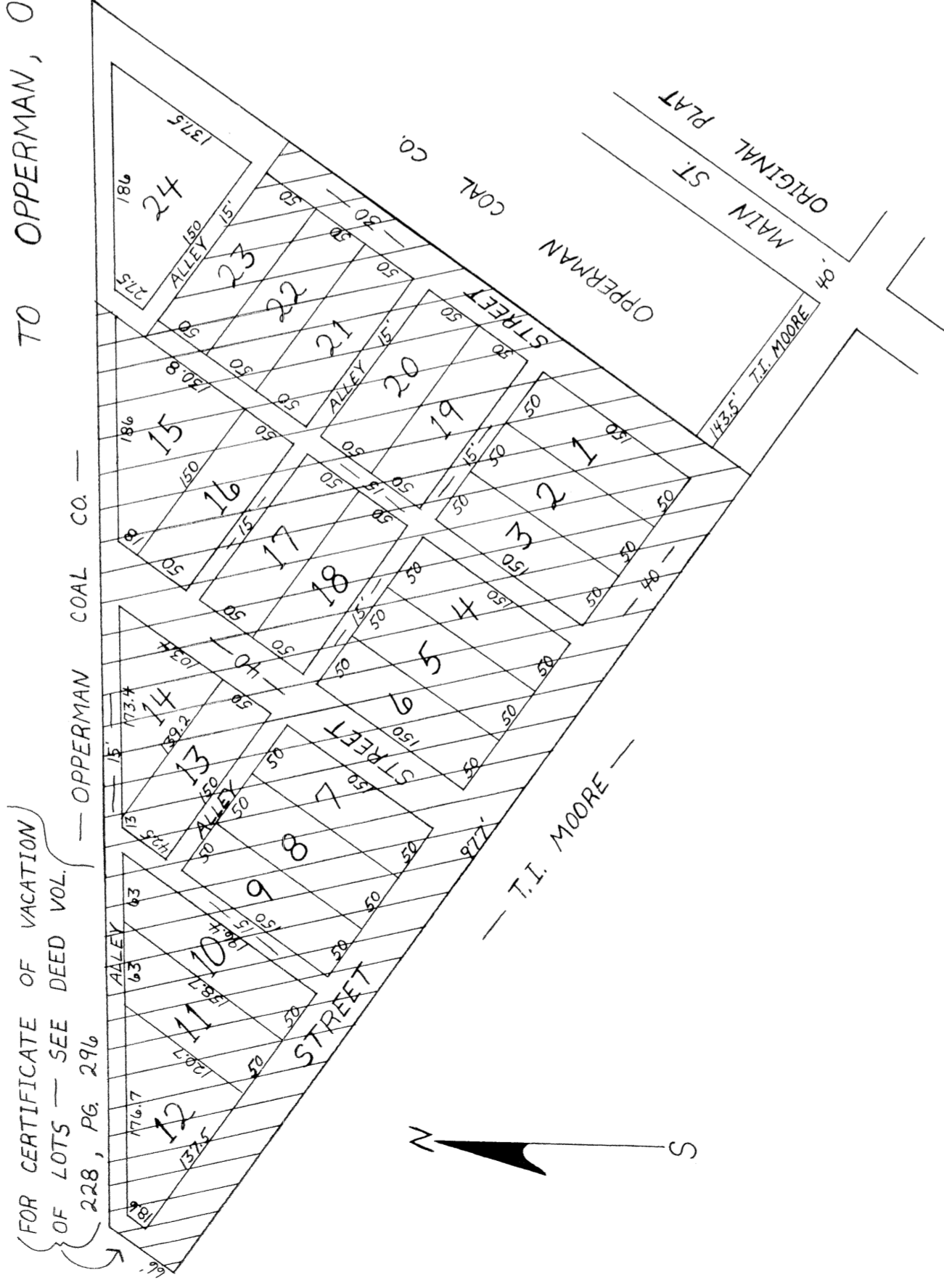


T. I. MOORE'S FIRST ADDITION

DESCRIPTION

THE ABOVE ADDITION IS LOCATED IN VALLEY TP. GUERNSEY COUNTY, OHIO AND EMBRACES A PART OF THE SOUTH EAST QUARTER OF SECTION FOURTEEN (14.) OF TOWNSHIP NINE (9) OF RANGE TEN (10) AND IS BOUNDED AND DESCRIBED AS FOLLOWS. BEGINNING AT SOUTH WEST CORNER OF THE ORIGINAL TOWN OF OPPERMAN, THENCE N. 52° 30' W. NINE HUNDRED FIFTH ONE (951) FEET: THENCE N. 37° 30' E. SIXTY SIX (66) FEET: THENCE EAST ONE THOUSAND AND TWO (1002) FEET: THENCE S. 37° 30' W. SIX HUNDRED TWENTY FOUR (624) FEET, THENCE S. 52° 30' E. ONE HUNDRED FORTY EIGHT AND FIVE TENTHS (148.5) FEET: THENCE S. 37° 30' W. FORTY (40) FEET CONTAINING SIX AND EIGHTY SIX ONE HUNDREDS (6.86) ACRES, AND CONSISTS IN THE SUBDIVISION OF THE SAME INTO LOTS, STREETS AND ALLEYS AS SHOWN IN PLAT.

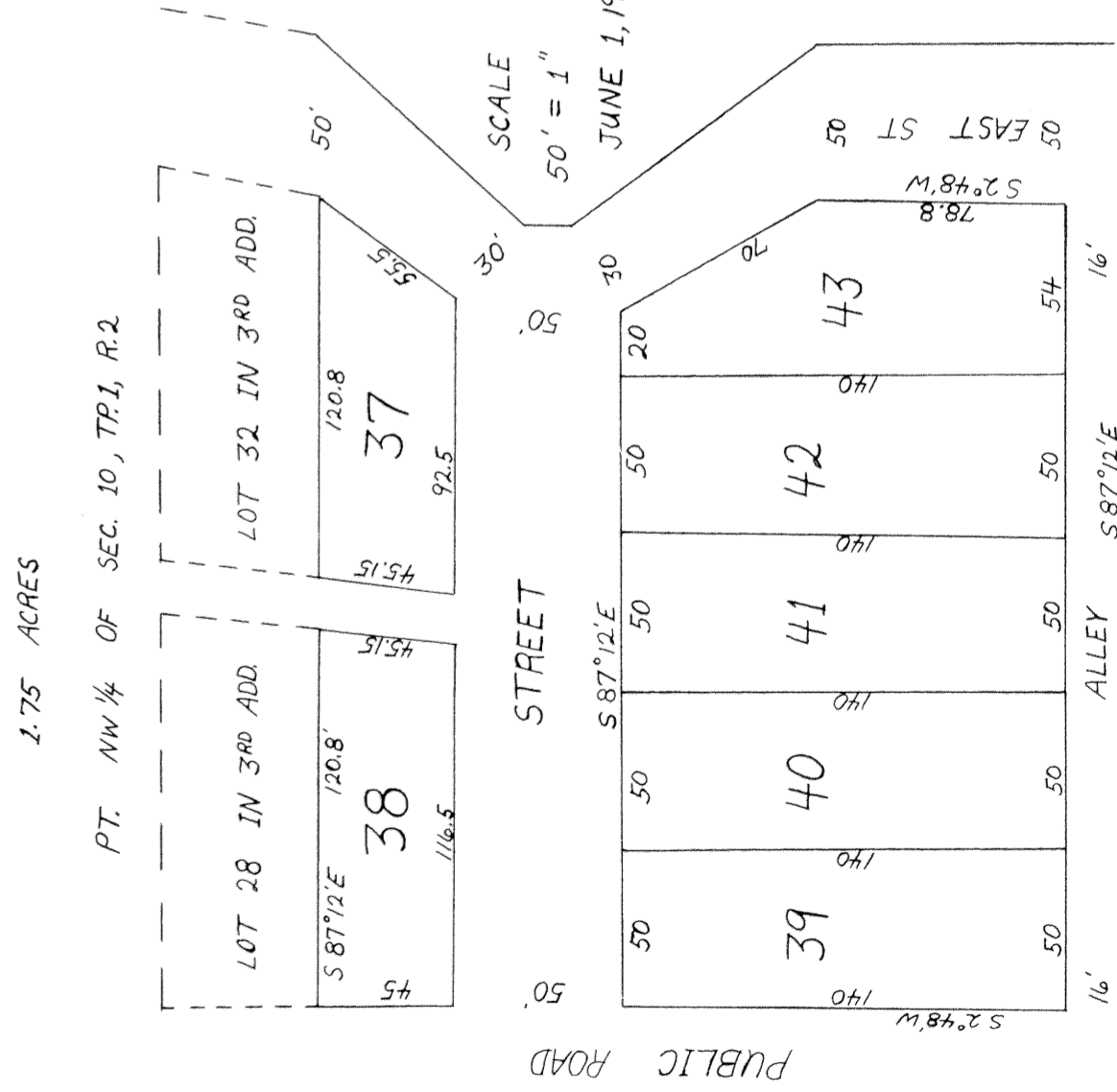
