



PLAT OF POWER'S ADDITION TO BYESVILLE, O.

AT THE REQUEST AND BY THE DIRECTIONS OF ANDREWS POWERS I LAID OUT THE FOLLOWING PIECE OF LAND TO WIT. BEING KNOWN AND BEING A PART OF OUT LOT NUMBER FOUR (4) IN WATSON'S ADDITION TO THE TO THE SOUTH WEST COR. OF DESCRIBED LAND THENCE WITH SAME LINE 365.5 FT. TO A FENCE THENCE NORTH 5 DEGREES AND 22 MIN. EAST 150.4 FT. TO THE SOUTH WEST SIDE OF C. & M. RAIL WAYS RIGHT OF WAY THENCE N.40°DEG. 37 MIN. WEST ALONG THE SAID RIGHT OF WAY 248.2 FT. TO A STAKE THENCE N.75 DEG. 33 MIN. WEST 208.4 FT. TO THE EAST SIDE OF EDWARDS LOT THENCE SOUTH 1°DEG. 56 MIN. W.36.5 FT. THENCE N.86°DEG. 32 MIN. W.65.5 FT. TO A FENCE THENCE S.5 DEG. 26 MIN.
