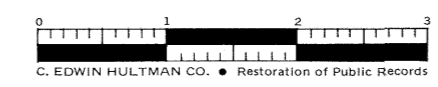

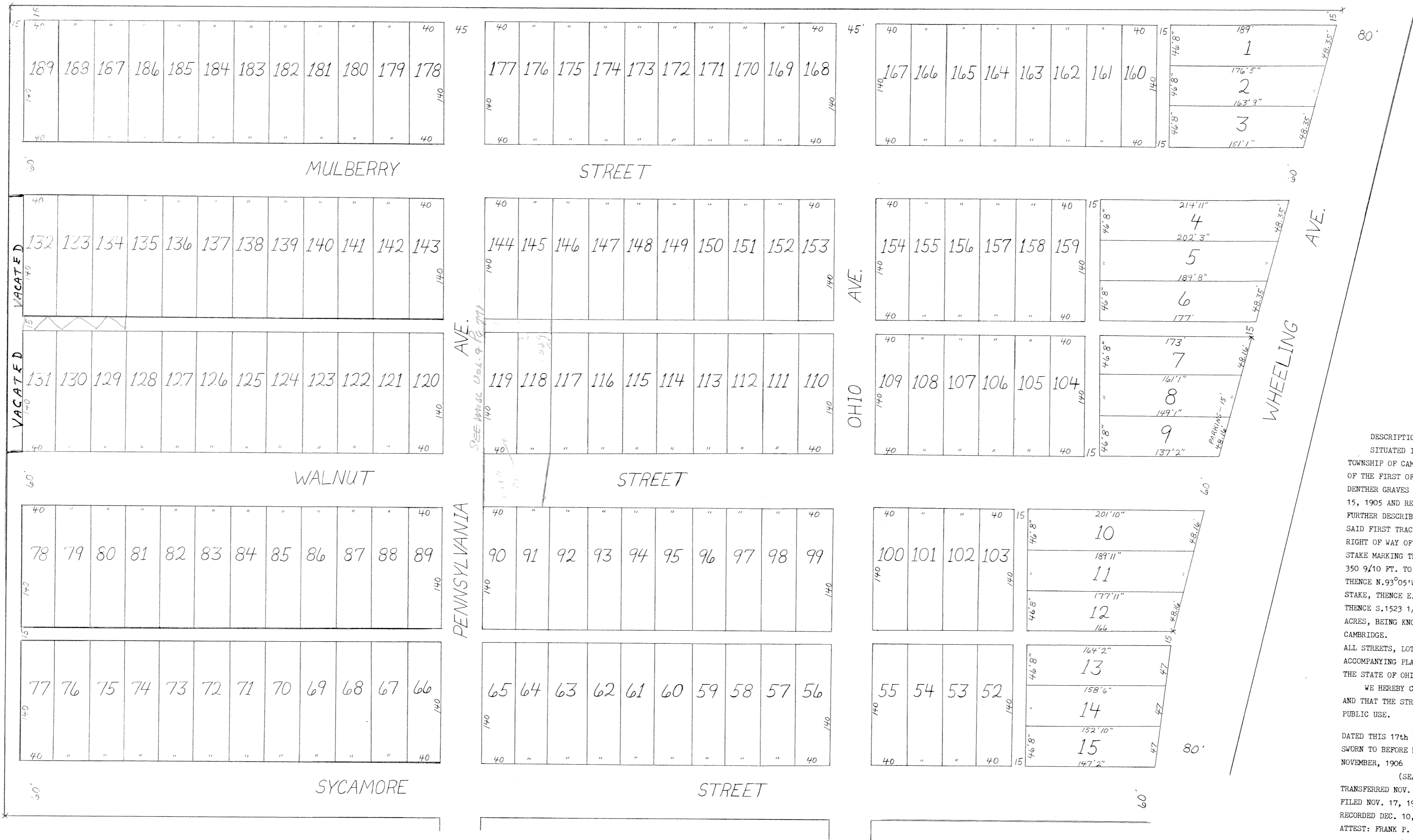

SUNNYMEADE ADDITION TO CITY OF CAMBRIDGE

OCTOBER 22, 1906

DESCRIPTION OF PART OF SUNNYMEADE ADDITION TO CAMBRIDGE. SITUATED IN THE COUNTY OF GUERNSEY IN THE STATE OF OHIO AND IN THE TOWNSHIP OF CAMBRIDGE AND BOUNDED AS FOLLOWS; BEING A PART OF THE FIRST OF TWO SEPARATE TRACTS OR PARCELS OF LAND CONVEYED BY J. DENTHER GRAVES AND WIFE TO JOHN AND JAMES R. MCBURNEY BY DEED DATED NOV. 15, 1905 AND RECORDED IN VOL. 86 PAGE 223 OF GUERNSEY COUNTY RECORDS: FURTHER DESCRIBED AS FOLLOWS; BEGINNING AT A STAKE ON THE EAST LINE OF SAID FIRST TRACT AND ON THE NORTH LINE OF THE EIGHTY FOOT (80) FT. RIGHT OF WAY OF THE NATIONAL ROAD, THENCE N.74°51'W.283 3/10 FT. TO A STAKE MARKING THE SOUTH EAST CORNER OF LOT NO. 7, THENCE N.75°39'W. 350 9/10 FT. TO A STAKE MARKING THE SOUTH WEST CORNER OF LOT NO. 12, THENCE N.93°05'W.216 6/10 FEET TO A STAKE THENCE N.1299 9/10 FT. TO A STAKE, THENCE E.925 FEET TO A STAKE ON THE EAST LINE OF SAID FIRST TRACT, THENCE S.1523 1/10 FT. TO THE PLACE OF BEGINNING AND CONTAINING 29 60/100 ACRES, BEING KNOWN AS A PART OF SUNNYMEADE ADDITION TO THE CITY OF CAMBRIDGE.
