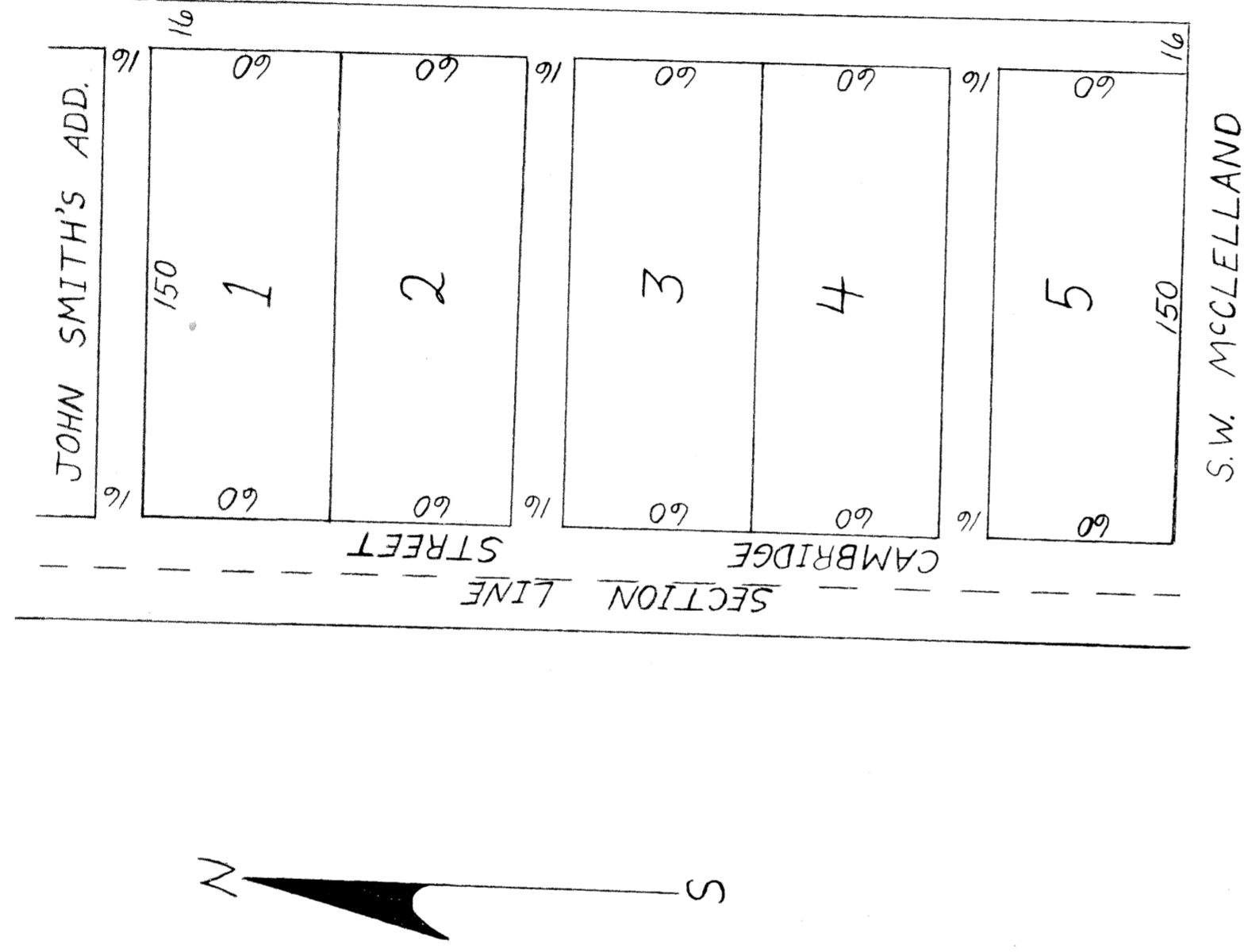


S. W. McCLELLAND'S ADDITION

DESCRIPTION

THE ABOVE ADDITION EMBRACES A PART OF THE NORTH-WEST QUARTER OF SECTION THIRTY THREE (33), TOWNSHIP NINE (9) RANGE TEN (10) AND IS BOUNDED AND DESCRIBED AS FOLLOWS. BEGINNING ON THE EAST SIDE OF CAMBRIDGE STREET AND ONE FOOT WEST FROM THE SOUTH WEST CORNER OF JOHN SMITH'S ADDITION: THENCE SOUTH 0°30' WEST THREE HUNDRED AND THIRTY TWO (332) FEET: THENCE SOUTH 89°30' EAST ONE HUNDRED AND SIXTY SIX (166) FEET: THENCE NORTH 0°30' EAST THREE HUNDRED AND THIRTY TWO FEET (332). THENCE NORTH 89°30' WEST ONE HUNDRED AND SIXTY SIX (166) FEET TO PLACE OF BEGINNING AND WITH STRIP EAST OF SECTION LINE CONTAINING ONE AND THIRTY NINE (1 39/100) ONE HUNDREDTH ACRES. THE PLAN OF SUBDIVISION IS AS SHOWN ON THE ACCOMPANYING PLAT AND THE LINEAR DIMENSIONS OF LOTS AND WIDTHS OF ALLEYS ARE GIVEN IN THE DENOMINATION OF FEET:
