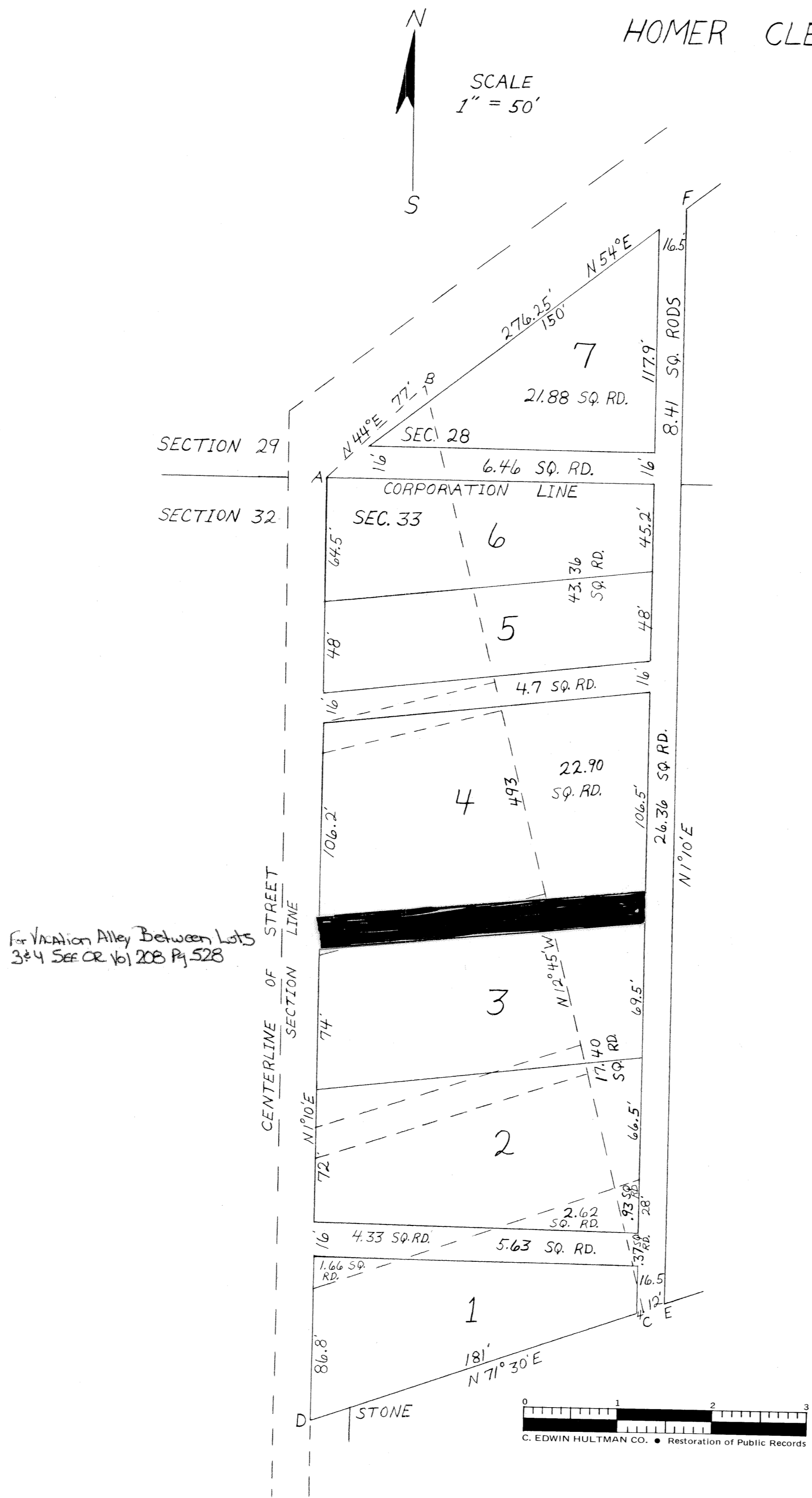

THE ABOVE PLAT EMBRACES CLEARY'S ADDITION TO CUMBERLAND, AS RECORDED APRIL 14, 1874, AND THE ADDITION OF A TRACT OF LAND THERETO LYING ALONG THE EAST SIDE OF SAID ADDITION AND PARTLY IN SECTION 33, TP.9, RANGE 10, WITHIN THE INCORPORATED VILLAGE OF CUMBERLAND AND PARTLY IN SECTION 28 OF SAME TOWNSHIP AND RANGE, AND IS BOUNDED AND DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTH EAST CORNER OF CLEARY'S ADDITION TO CUMBERLAND" THENCE N.71°30'E. TWELVE (12) FEET TO EAST SIDE OF ALLEY, THENCE 1°10'E. FIVE HUNDRED AND SEVENTY SIX (576') FEET ALONG EAST SIDE OF ALLEY, THENCE S.54°W. ONE HUNDRED AND FIFTY (150) FEET, TO THE EAST LINE OF CLEARY'S ADDITION: THENCE ALONG SAID EAST LINE S.12°45'E. FOUR HUNDRED AND NINETY THREE (493) FEET TO PLACE OF BEGINNING, CONTAINING NINETY EIGHT ONE HUNDREDTH (98/100) ACRES. AND CONSISTS IN THE SUBDIVISION OF CLEARY'S ADDITION AND THE TRACT ADDED THERETO INTO LOTS AND ALLEYS AS SHOWN ON THE PLAT. THE LINEAR DIMENSIONS ARE GIVEN IN THE DENOMINATION OF FEET AND DECIMALS THEREOF AND ACRES IN SQUARE RODS. I CERTIFY THAT THE ABOVE NOTES ARE CORRECT.
