


THE VILLAGE OF BYESVILLE, OHIO

AT THE REQUEST AND BY THE DIRECTION OF THE PROPRIETOR J.R. SMITH, I MADE A SURVEY OF THE FOLLOWING PIECE OF LAND SITUATED IN THE TOWNSHIP OF JACKSON, COUNTY OF GUERNSEY AND STATE OF OHIO AND IN THE CORPORATE LIMITS OF BYESVILLE, OHIO AND BEING A PART OF MILITARY LOT 2 IN FIRST QR. TOWNSHIP ONE OF RANGE TWO. BEGINNING FOR THE SAME AT A STAKE IN THE NORTH LINE OF NORTH HIGH STREET AND WEST LINE OF THE PENNSYLVANIA RAILROAD RIGHT OF WAY RUNNING THENCE NORTH 86 DEG. 15 MIN. WEST ALONG THE SAID NORTH HIGH STREET 288 FEET 4 INCHES TO A STAKE IN THE EAST LINE OF WM. TRENNER'S LAND 291 FEET TO THE WEST LINE OF THE SAID PENNSYLVANIA RAILROAD LAND (OR RIGHT OF WAY)

THENCE SOUTH EAST ALONG THE SAID RIGHT OF WAY 407½ FEET TO THE PLACE OF BEGINNING CONTAINING 96/100 ACRES NORE OR LESS. I LAID OUT THE DESCRIBED PIECE OF LAND IN LOTS AND ALLEYS WHICH ARE MARKED IN FIGURES ON THE LINES OR SPACES TO WHICH THEY REFER (THE NUMBER OF EACH LOT IS MARKED ON ITS CORRESPONDING LOT.
