

AT THE REQUEST AND BY THE DIRECTIONS OF JOHN HAMILTON, A.E. FLETCHER. B.V. WITTEN AND H.H. WILSON, I, DILLON MARSH MADE A SURVEY OF AND PLATTED THE FOLLOWING DESCRIBED PIECE OF LAND, KNOWN AS A PART OF THE NORTH PART OF THE EAST PART OF THE WEST HALF OF SECTION (1) TOWNSHIP (8) RANGE (9) AND COMMENCING FOR THE SAME ON THE HALF SECTION LINE AT A STAKE IN THE CENTER OF COUNTY ROAD WHERE SAID ROAD CROSSES SAID HALF SECTION LINE THENCE N.4°5'E. ALONG SAID LINE 1198.9 FEET TO A STAKE; THENCE N.86°5'W. 182.8 FEET TO THE WEST LINE OF SAID LAND, THENCE 4°5'W. 709.4 FEET TO A STAKE IN THE CENTER OF THE HARTFORD AND SARAHSVILLE ROAD; THENCE S.52°45'E. ALONG THE CENTER OF SAID ROAD WITH THE MEANDERINGS 283.47 FEET TO A STAKE; THENCE S.61°48'E. 499.54 FEET TO A STAKE IN CENTER OF ROAD; THENCE S.88° 10'E. 187.92 FEET TO A STAKE IN ROAD; THENCE S.87°00'E.671.45 TO THE PLACE OF BEGINNING, CONTAINING 48.263 ACRES MORE OR LESS. I LAID OUT SAID LAND IN LOTS, STREETS, AND ALLEYS AS SHOWN IN PLAT. THE DISTANCES ARE MARKED ON OR NEAR THE LINES OR SPACES TO WHICH THEY REFER AND ARE MARKED IN FEET AND DECIMALS. THE LOTS ARE NUMBERED ON ITS CORRESPONDING LOT. THE TRACTS ARE NUMBERED AS SHOWN ON PLAT, THE NUMBER OF ACRES ARE MARKED ON EACH TRACT. I HEREBY CERTIFY THE ACCOMPANYING PLAT TO BE A TRUE REPRESENTATION OF SAID SURVEY.
