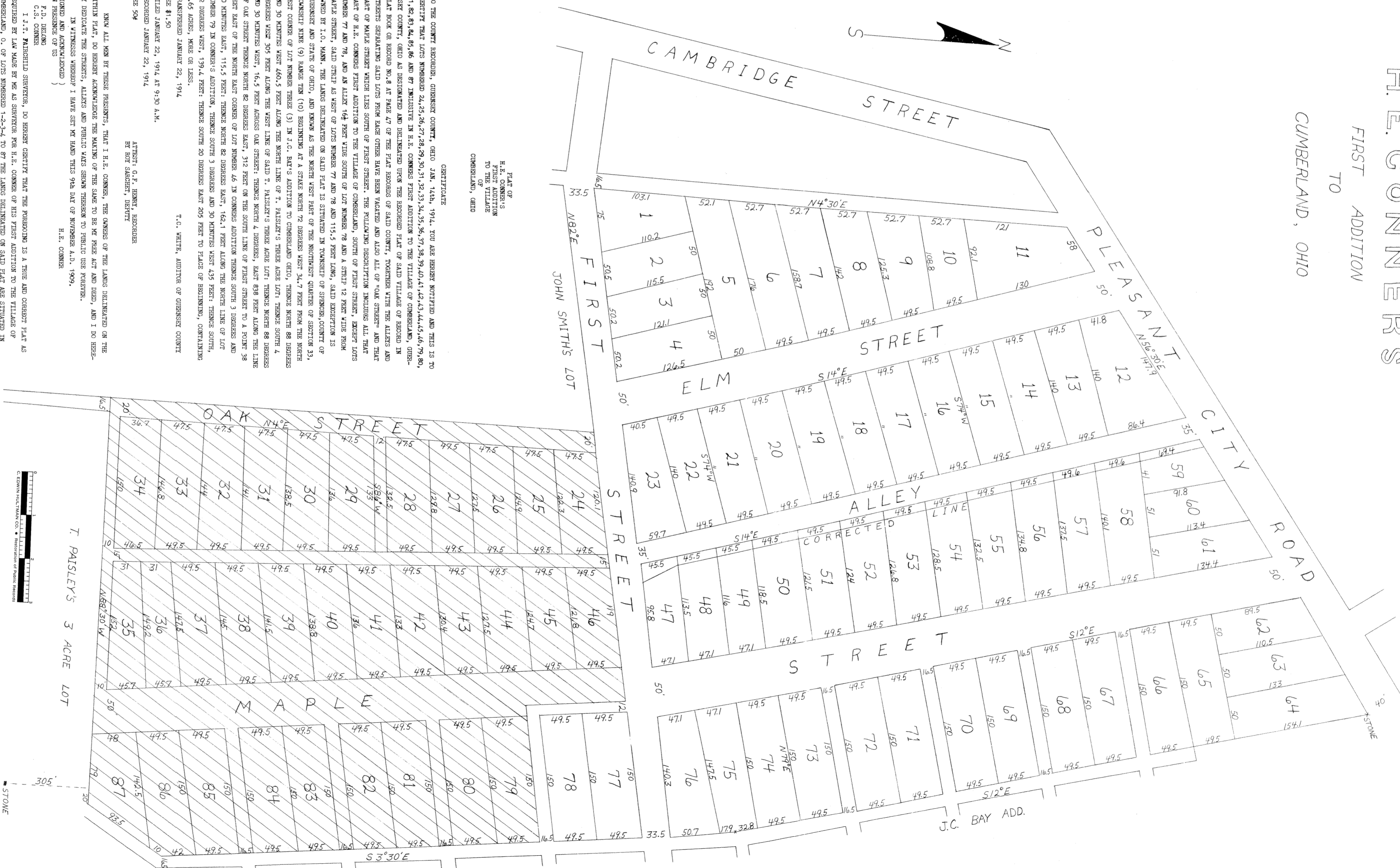

E. CONNERS FIRST ADDITION TO THE VILLAGE OF CUMBERLAND, COUNTY OF GENESEE, EXCEPT LOTS NUMBER 77 AND 78, AND AN ALLEY 164 FEET WIDE SOUTH OF LOT NUMBER 78 AND A STRIP 12 FEET WIDE FROM MAPLE STREET, SAID STRIP AS WEST OF LOTS NUMBER 77 AND 78 AND 115.5 FEET LONG, SAID EXCEPTION IS OWNED BY I. O. MANN, THE LANDS DELINEATED ON SAID PLAT IS SITUATED IN TOWNSHIP 9 NORTH, QUARTER 3 OF GENESEE AND STATE OF OHIO, AND KNOWN AS THE NORTH WEST PART OF THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 9 NORTH (9) RANGE 10 (10) BEGINNING AT A STAKE NINE 72 DEGREES WEST 34.7 FEET FROM THE NORTH WEST CORNER OF LOT NUMBER THREE (3) IN J. O. BAY'S ADDITION TO CUMBERLAND, OHIO, THENCE NORTH 88 DEGREES AND 30 MINUTES WEST 460.5 FEET ALONG THE NORTH LINE OF T.
