Description of Neelands Hub Addition  
to Hartford.

The above addition embraces a part of the west half of the northeast quarter of Section No. 20, Township No. 2 East of Range No. 10 West and is situated in Liberty Township, Lawrence County, Ohio and is bounded as follows:— Beginning on the corner at a point on the south line of the corner tract, one foot westerly from corner at the southeast corner of Adams; thence along said south line N 85° 30' W say hundred and forty-two feet; thence N 0° 14' W eighty-five feet to station N 85° 30' W one hundred and forty-two feet of public road; thence along said line of public road S 6° 14' W one hundred and twenty feet to the north line of said tract; thence along said north line S 85° 30' E one hundred and forty-two feet to a point one foot westerly from corner at the northwest corner of Adams; thence along said north line with said line of course S 5° 07' W one hundred and twenty feet and one hundred and twenty feet to place of beginning containing forty-one (41) acres, more by deed.

But corners in the subdivision of the above into lots, streets and alleys as shown on the above map. The linear division of the lots, the width of the streets and alleys appear on the map in the column. It being hereby certified that the above is a correct, true and faithful plan of said corner as shown on the accompanying map.
