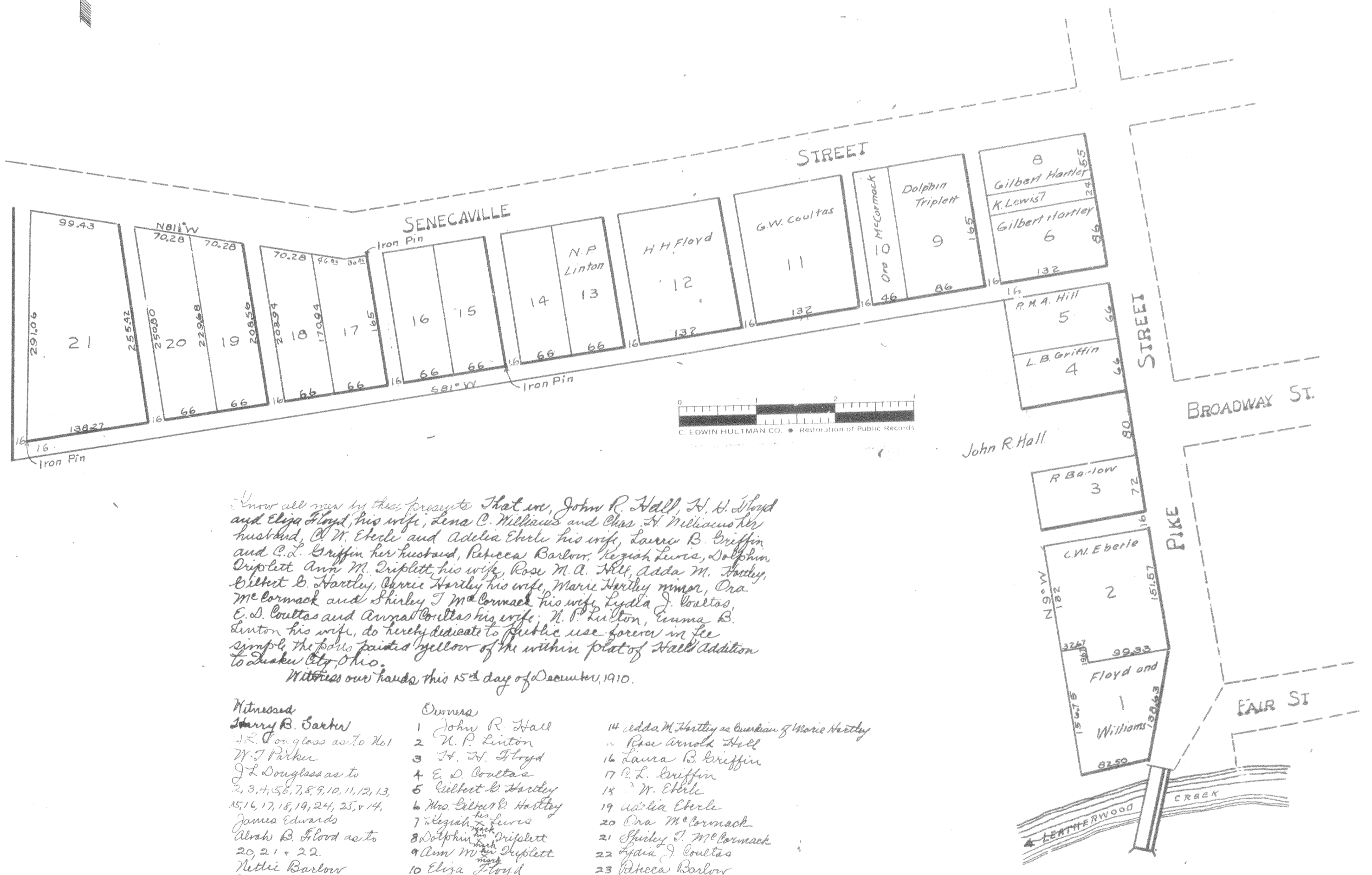


# HALL'S ADDITION TO QUAKER CITY, O.
